In producing herewith the accused namely Sandip Mahata (25 Yrs), S/o- Lt. Sunil @ Bhusan Mahata of Vill- Janara, PS- Manbazar, Dist-Purulia and also seized vehicle (Tractor) bearing Registration No. WB33C-7014 attached with trolley loaded with sand appx 100 Cft. The fact of the case in brief is that on 23/24-11-2021 I along with C/ 1535 Dharanidhar Mondal and C/1130 Asik Ansari of Kenda PS were performing night mobile duty. During night mobile duty on 24/11/2021 at about 02.25 hrs. when we reached near at Dakakendu More found that the above noted tractor was coming from Mahara village side under Manbazar PS. On seeing the Police party driver of the said vehicle (tractor) stopped his tractor in a distance and he tried to fled away after keeping the tractor near at Dakakendu More but we manage to detain the driver of the said tractor having Reg. No. WB33C-7014. On demand the driver of the said vehicle failed to produce any valid documents in respect of the said tractor attached with trolley and loaded sand approx.100 cft. It ascertained that the owner and driver of the said tractor attached with trolley loaded with sand by illegal manner for selling the same to make profit by dishonestly in a clandestine business. So seized the tractor bearing Reg. No. WB33C-7014 attached with trolley loaded with sand under proper seizure list in presence of available witnesses duly signed by them and also arrested the driver of the said tractor after preparing memo of arrest duly signed by the accused driver. I also informed him regarding ground of arrest and arranged to inform his relatives. Thereafter arrange driver from my source and brought the tractor at Kenda PS. So there have sufficient reason to belief that driver and owner of the said seized tractor procured the said sand by fraudulently means or theft by any means for transporting the same to clandestine business.

Under the above facts and circumstances kindly take lawful action against the owner and arrested driver of the tractor having Registration No. WB33C-7014 attached with trolley loaded with sand approx. 100 CFT.
