Sub: Prayer for starting a specific case against arrested accd. Bishnupada Kumar (52 yrs) S/O Late Balaram Kumar of vill.- Kochahatu, PS - Kotshila, Dist- Purulia.

Sir,

In producing herewith arrested accd Bishnupada Kumar (52 yrs) S/O Late Balaram Kumar of vill.- Kochahatu, PS - Kotshila, Dist- Purulia with arrest Memo, along with seized articles viz (1) 25 packets of Crackers designed as Rolex Chocolate, each packet contains 12 pcs of crackers ,Total (25 x 12) =300 pcs, under proper seizure list, I beg to report that, on 03.11.2021 at about 13.55 hrs during my Anti crime mobile duty received a telephonic information from my source that one person is selling crackers illegally in his stationery shop. Accordingly I informed the matter to O/C Kotshila PS and as per his direction myself along with C/332 Ashok Kr. Kandou, C/633 Dasarath Singh Mura started for working out the information Kotshila PS C.C. No 2578/21 dated- 03.11.2021 and briefing them carefully about the information and my plan to catch him red handed. We reached at Kotshila Bazar on 03.11.2021 at 14.15 hrs. and proceeded to the spot on feet and as per public information identified the shop. We entered into the shop and seeing police personnel 2/3 persons fled away from the shop and we detained one person who on asked revealed himself as Bishnupada Kumar (52 yrs) S/O Late Balaram Kumar of vill.- Kochahatu, PS - Kotshila, Dist- Purulia and identified himself as the owner of the shop and when I told him about the information, he fully confessed that he used to sell crackers and on searching the shop recovered (1) 25 packets of Crackers designed as Rolex Chocolate, each packet contains 12 pcs of crackers ,Total (25 x 12) =300 pcs and on being demanded he failed to produced any license or constitutional papers in favour of keeping, storing or selling any crackers or combustible or fire articles and also confessed that inspite of knowing such type of fire cracker banned by the Apex Court and it fully well that it is strictly illegal and unlawful to sell, keep or store, he had been selling those crackers after having a huge store of it in the shop from the past few days. Accordingly I seized the above mentioned fire crackers from his exclusive possession after furnishing proper seizure list and arrested him accordingly for his negligent conduct with respect to fire or combustible or explosive substances which can endanger to human life. It is worthy enough to be noted that no public witness found at that time and hence the seizure was done under the presence of my accompanying forces.

Hence I pray that a specific case may kindly be started against above noted arrested accused person under proper section of law and arrange for its investigation.
