Sir,

In producing here with the arrested Accused person namely (1) Priyaranjan @ Mithun Kumar (31 yrs) s/o Aditya Kumar (2) Amir Chand Kumar (25 yrs) s/o Mukhtiram Kumar both of vill.- Belyadih, PS – Kotshila, Dist.- Purulia as disclosed by the arrested accused persons along with seized articles under proper seizure list (enclosed here with) i.e. (i) One Red Colour Hero Super Splendor Motor Cycle bearing registration no. JH09AD/1575 (ii) One white plastic bag (iii) Exhibit Mark-'A' i.e. one white colour transparent plastic Jaricane along with red colored cap containing ``6700 grms (including Jaricane) of light red colored codeine mixture (from which mother samples 4 bottles of 100 grms each taken out for test samples and security samples marked as Exhibit 'B1' & 'B2' & C1' & 'C2'), (iv) Exhibit mark – 'B1' & 'B2' containing 100 grms each of codeine as test sample (including bottle). (v) Exhibit mark 'C1' & 'C2' containing 100 grams each of codeine as security sample (including bottle). All Exhibits are in properly sealed and labeled condition under proper seizure list.

I, SI Debabrata Chakraborty of Kotshila PS do here by lodge this complaint as suo-moto to the effect that today (15/11/2021) at 23.35 hrs duty officer of Kotshila P.S SI Ramu Gurung received a telephonic information from an unknown caller that 02 (two) persons would be coming from Jharkhand via Chitmu - Kotshila village road in a Red Colour Hero Super Splendor Motor Cycle bearing registration no. JH09AD/1575 and may proceed towards Kotshila side through Chitmu village road with some contraband goods suspected to be narcotic substance in order to sell the same. On received such information SI Ramu Gurung immediately diarized the fact in GD vide Kotshila PS GDE No 587 dated-15.11.2021 and informed the matter to O/C Kotshila PS who please directed me to proceed to work out the information. As such as per his direction I SI Debabrata Chakraborty along with (i) ASI- Pankaj Kr. Gupta (ii) C/1279 Bhabataran Mahato (iii) C/983 Radhakanta Kisku (iv) PD/180 Dilip Kr. Das, all are Kotshila P.S. left at 23.55 hrs for Chitmu village after preparing inventory list, by Govt. Vehicle No WB 26C/7292 attached to Kotshila PS equipped with govt. supplied arms and ammunition, Investigation kit, weighing machine, white paper, gala, white cloth, carbon paper, stamp pad, empty plastic bottle 06 pcs, seal of Kotshila PS, envelope etc. vide Kotshila PS CC No. 2682/21 Dt. 15.11.2021 & Kotshila PS GDE No 588 dt. 15.11.2021.

At about 00.25 hrs reached near to Khatanga Bat tala near Khatanga village on Chitmu- Kotshila village road under Kotshila PS. After reaching, the said place Govt. vehicle was kept in reasonable distance conducted ambushed up to 00.55 hrs on 16.11.2021. At that time found 02 (two) persons approaching on a motor cycle from Chitmu village side with a white plastic bag towards Khatanga side. While they reached closer to police party we surrounded them and focused our torch light and detained them. On asked they disclosed their identity as (1) Priyaranjan @ Mithun Kumar (31 yrs) s/o Aditya Kumar (2) Amir Chand Kumar (25 yrs) s/o Mukhtiram Kumar both of vill.- Belyadih, PS – Kotshila, Dist.- Purulia. We informed them that we have specific information that they have illegal narcotic substance and they admitted that they procured and carrying codeine mixture without any valid papers and others.

I also issued notice as per NDPS Act to the detained persons in order to conduct their search by a Executive Magistrate or by any Gazetted Police Officer. They informed in writing that they have no objection if the search conducted either by any Gazatted Police Officer or by any Executive Magistrate. Accordingly I informed OC Kotshila P.S and CI, Sadar, Purulia Insp. Shri Sanjib Biswas at about 01.15 hrs on 16.11.2021 regarding the whole things.

At 01.25 hrs, CI, Sadar Purulia informed me over telephone that no Executive Magistrate could be made available as such odd hours of the night. As such as per request of the above noted 02 (two) detained persons CI Sadar Purulia proceeding to the spot.

At about 02.25 hrs Insp. Shri Sanjib Biswas, CI, Sadar Purulia reached there and I narrated him about the development. He disclosed his identity before the detained persons and asked me to issue notice to the detained persons, offering them to search the available police personnel present there, they conducted a search of all the members of us but nothing objectionable could be found on our person except our personal belongings, govt. arms ammunitions and items mention in the inventory list.

As per direction of Insp. Shri Sanjib Biswas CI Sadar Purulia, I conducted search of (1) Priyaranjan @ Mithun Kumar (31 yrs) s/o Aditya Kumar (2) Amir Chand Kumar (25 yrs) s/o Muktiram Kumar both of vill.- Belyadih, PS – Kotshila, Dist.- Purulia in between 02.35 hrs to 02.45 hrs.

During search I recovered one white plastic bag in which found one white colour transparent plastic Jaricane along with red coloured cap containing light red coloured liquid. On interrogation they admitted that it is the codeine mixture and they are habituated in dealing of such clandestine illegal business of Codeine for commercial purpose for their wrongful gain, knowing the same is a punishable offence. On demand they failed to produce any documents or justify regarding the storage of huge quantity of contraband codeine mixture. According to the direction of CI, Sadar Purulia, I weight the Jaricane and it resulted in 7100 grams including Jaricane in weighing machine. On reasonable belief, an offence has been committed in respect of recovered liquid substance believe to be codeine mixture from which 100 gram each were taken in 04 (four) plastic bottles 02 (two) as test sample and 02 (two) security sample from mother sample. The said articles were seized U/S 43 of NDPS Act 1985 under proper seizure list duly signed by the witnesses as well as the accused persons in between 02:45 hrs to 03:15 Hrs.No public witness was available there due to the dead hours of night. I also supplied a copy of seizure list to the accused persons. I arrested the detained persons maintaining all formalities. The seized bottles were properly labeled and sealed.

In between 03.25 hrs. to 03.55 hrs. I prepared another inventory list containing weighing machine, some white paper, used gala, rest white cloth, used carbon paper, stamp pad, seal, burnt candle, two empty small bottles, one Jaricane and four small bottles (the Jaricane consists of 6700 gram and other four bottles contains 100 gram each of seized codeine mixture) in presence of witnesses and accused persons. After that both the accused persons were arrested after maintaining all formalities in-between 04:05 hrs and 04:10 Hrs and also issued memo of arrest. The entire process was supervised and directed by Shri Sanjib Biswas , CI Sadar, Purulia.

The accused persons are liable for prosecution U/S- 21(c) /29 of NDPS Act. 1985 as amended up to date.

Under the above fact and circumstances I like to lodge an FIR against (1) Priyaranjan @ Mithun Kumar (31 yrs) s/o Aditya Kumar (2) Amir Chand Kumar (25 yrs) s/o Muktiram Kumar both of vill.- Belyadih, PS – Kotshila, Dist.- Purulia U/S- 21 (c) /29 of NDPS Act. 1985 as amended up to date and arrange for its investigation.
