Sir,  
In producing herewith arrested accused namely Dhananjay Dan (50) s/o Lt Kashinath Dan of Gopalnagar Main Road, PS- Manbazar, dist- Purulia with seized articles – (1) 02 Bundles Burimar Chaklet Bomb containing 10 Packets each, (2) 5 Bundles Rolex Chaklet bomb containing 06 packets each (3) 03 Packets Sanlight's 2000 chain crackers (4) 01 packets sunlight's 10000 chain crackers I, ASI Subhendu Mahato of Manbazar PS like to note that, in course of my mobile duty, today at 14:05 hrs I got a source information that, above person has stocked prohibited firecrackers and also selling the same in his Pan shop styled as Bikash Varity located at Gopalnagar Main Road. Informed the fact to O/C, Manbazar PS and myself along with my accompanying force C/200 Dasarath Mahato, NVF/537 Asit Kr Mahato vide Manbazar PS CC No 4274/21 dtd 03.11.21 had been in the shop of above person. Reaching there I observed that, above articles have been stocked by him. Being asked he stated that, he has stocked those articles for selling to public. He failed to produce to show any document for stocking such combustible and explosive substances.

So, there is every reason to believe that, knowingly he has conducted negligent act in respect of such explosive and combustible substances which are endanger to human life and to cause injury to human life. He has also violated the order of the hon'ble apex court and order of West Bengal Pollution control Board vide Memo No. 321-3L/WPB-E (VI)/2020 dtd 26.10.2021, which is recently promulgated by these authority. He also did not cooperated with me for proper enquiry of the matter.

So, I arrested him and seized all the above articles and brought to PS.

Therefore, I request you that, proper legal action may be taken against him.
