Sub: Prayer for starting a specific case.

Respected Sir,

In producing herewith arrested accused person namely Pratap Shaw @ Pappu (49) S/O-Lt. Arjun Shaw of Vill-Saltore, PS-Neturia, Dist-Purulia with seizure of 17 pcs Sealed bottles of Bumper Country spirit containing 300 ml each (MRP Rs. 28/Each) which were seized under proper seizure list.

I beg to submit that today (26.11.21) while I, SI Abhijit Das, along with force were performing evening mobile duty vide Neturia PS GDE No-1140 Dt. 26.11.21 and acting on source information after consulting you at about 19:05 hrs reached at Saltore village and held raid in the sweet shop of Pratap Shaw @ Pappu (49) S/O-Lt. Arjun Shaw of Vill-Saltore, PS-Neturia, Dist-Purulia and found that the above noted person was keeping / selling liquor which were kept in his shop, on demand Pratap Shaw @ Pappu failed to produce any valid documentary authority in respect of selling of liquor as well as nobody turned up to produce any valid documents. As such he committed offence u/s 46 A (c) B.E. Act and he was arrested U/S-67 BE Act and also 17 pcs Sealed bottles of Bumper Country spirit containing 300 ml each which were seized under proper seizure list duly signed by witnesses and labeled 01 (One) bottle at the time of seizure. During arrest, I followed all the guidelines of Ld. Apex Court, NHRC & WBHRC and the ground of arrest was duly notified and informed his relative, issued arrest memo u/s- 50 Cr. P.C. and handed a copy of the same to arrestee.

The arrested accused namely Pratap Shaw @ Pappu (49) S/O-Lt. Arjun Shaw of Vill-Saltore, PS-Neturia, Dist-Purulia has committed offence u/s 46 A(c) B.E. Act, 1909 for unauthorized possession and sale of liquor.

It may note here that during raid (1) C/1568 Debjyoti Sinha (2) C/1361 Munshi Kamal Hassan and (3) C/939 Laltu Paul all are of Neturia PS accompanied me.

Under the above facts and circumstances I therefore pray that a specific case may kindly be started against Pratap Shaw @ Pappu (49) S/O-Lt. Arjun Shaw of Vill-Saltore, PS-Neturia, Dist-Purulia under proper section of law.
