Sub: Complain to start a specific case.

Sir,

In producing herewith one seized motorcycle having registration No- WB 62M/6764, Engine No-JA07ABL9K23494, Chassis No-MBLJAW171L9K14107 (Hero Super Splendor) do hereby lodge a complaint to the effect that today on 14.11.2021 during verifying the confessional statement of PC accused namely Samser Ansary @ Gera (30) S/O-Sahid Ansary of Vill-Dumurhir, PS-Neturia, Dist-Purulia in c/w Neturia PS Case No- 79/2021 Dt. 28.08.2021 U/S- 379 IPC, I, SI Biswajit Banerjee, along with force and above noted PC accused had been to Dumurhir village at 18:05 hrs and he took us to a pond styled as "Natun Bandh" behind Dumurhir Jr. High School and recovered one motorcycle which was kept under water of "Natun Bandh" as stolen property as shown and identified by him. We took the motorcycle out of water & after verification we found that having registration No- WB 62M/6764, Engine No-JA07ABL9K23494, Chassis No-MBLJAW171L9K14107 (Hero Super Splendor). On demand neither he nor his family members could produce any relevant papers/documents in respect of this motorcycle having No- WB 62M/6764. So, there is sufficient reason to believe that he possessed this motorcycle by any unfair means either by stealing this motorcycle or by receiving this motorcycle as stolen property. Accordingly, I seized that motorcycle having registration No- WB 62M/6764, Engine No-JA07ABL9K23494, Chassis No-MBLJAW171L9K14107 under proper seizure list duly signed by the witnesses. Thereafter, I brought the seized motorcycle at Neturia PS.

So, it is reasonable to believe that the above noted PC accused, stolen the above noted motorcycle for its disposal in a clandestine manner for his wrongful gain. On further enquiry it also revealed that he is habitually involved in criminal cases. He was previously involved in Neturia PS case No-10/17 dated 02/02/17 U/S- 399/402 IPC & 25/27 Arms Act and also involved in c/w Raghunathpur PS Case No 21/21 dtd 08.03.2021 U/S 25(1)(a)/27 Arms Act 1959. So, he has committed offence U/S- 379/411/413/414 IPC.

Under the above circumstances a specific case may kindly be started against Samser Ansary @ Gera (30) S/O-Sahid Ansary of Vill-Dumurhir, PS-Neturia, Dist-Purulia.
