Sir,

I, Sekhar Kr Mitra, Inspector of Police, DEB, Purulia, do here by lodge complaint being produced the following seized articles (i) 26 (Twenty Six) Pcs domestic LPG cylinders of Indane company fully loaded with LPG & sealed condition (ii) 07 (Seven) Pcs domestic LPG cylinders of HP company which are empty (iii) 05 (Five) Pcs Nozzle device (Size - 3-½ Inch) (iv) 01 (One) Nozzle device (Size - 10 Inch) appearing to have been made of copper & steel used for re-filling gas from one to another cylinders (v) 01 (one) Electronic weight machine (vi) 02 (Two) Pcs empty small Gas cylinders to the effect that today on 12.11.2021 on the basis of secret and credible information I, along with ASI Swapan Chakraborty, W/C 88 Pradyut Mandal, HG/1427 Benimadhab Char, HG/1590 Bishnupada Mahato all of DEB Purulia had been to Para PS and submitted one requisition to OC Para PS for rendering assistance and the credible information at Para PS at 10.45 hrs. has been noted vide Para PS GDE No. 450 dtd. 12.11.2021 at 11.25 hrs. Thereafter we along with officer and force of Para PS left for Nadiha village under Para PS to work out the information. On arrival near Nadiha more at about 13.25 hrs to work out the information and holding raid, search and seizure in the shop of one Mrinal Bhattacharjee (33yrs) S/o Sunit Bhattacharjee of Village- Routara, P.O- Nadiha, PS- Para, Dist Purulia. Prior to holding raid in the house, we noticed huge nos. of domestic LPG cylinder kept inside the shop along with apparatus which is used for refilling LPG from one to another cylinder. The owner namely Mrinal Bhattacharjee was asked to produce valid documents / license for running his business in respect of possessing such domestic LPG cylinders and also such business of refilling, but the owner failed to produce any valid documents / license for running such illegal business. Thereafter myself along with accompanied officers and force held raid in the shop of Mrinal Bhattacharjee (33yrs) S/o Sunit Bhattacharjee of Village- Routara, P.O- Nadiha, PS- Para, Dist Purulia, after observing all formalities relating to search and seizure in between 14.45 hrs to 16.25 hrs.

As such I seized the articles with proper labeling in presence of police witnesses under proper seizure list from the shop of Mrinal Bhattacharjee.


Mrinal Bhattacharjee (33yrs) S/o Sunit Bhattacharjee of Village- Routara, P.O- Nadiha, PS- Para, Dist Purulia failed to produce any valid documents / papers for running such business hence he violated the provisions laid in rule 3 of West Bengal Cooking Gas (Licensing & Control order) 1985. Hence he has committed an offence punishable u/s 7(i)(a)(ii) of E.C.Act'1955.



In course of local enquiry it revealed that said Mrinal Bhattacharjee is running clandestine business of LPG Gas Cylinder and also selling LPG after refilling in other cylinder since long without having any authority or license and only for causing his wrongful gain and causing loss of revenue to Govt. The above noted seized articles as mentioned in S/L No. 1, 2, & 6 left in Zimma to one office manager of ZICO HP GAS dealer namely Bivash Mahato S/o Sridam Mahato of Village - Chanchara, PS- Purulia (M), Dist.- Purulia vide his dealer code no. 14387800 situated at Podlara village PS- Purulia (M), Dist.- Purulia in anticipation of kind approval of the Ld. ACJM Raghunathpur Court, Purulia.

I therefore request you to start a case u/s 7(i)(a)(ii) of E.C.Act'1955 against accused Mrinal Bhattacharjee (33yrs) S/o Sunit Bhattacharjee of Village- Routara, P.O- Nadiha, PS- Para, Dist Purulia.


As per kind order of Dy. SP(DEB), Purulia SI Amaresh Das of DEB, Purulia will investigate the case.
