That on the day of incident at relevant point of time Accused persons exploded some objectional fire crackers in front of house of the complainant's uncle Amar Bistu besides that Accd. persons, intentionally exploded crakeres on the self of window of complainant's uncle . Be noted house of complainant and his uncle are within common compound.

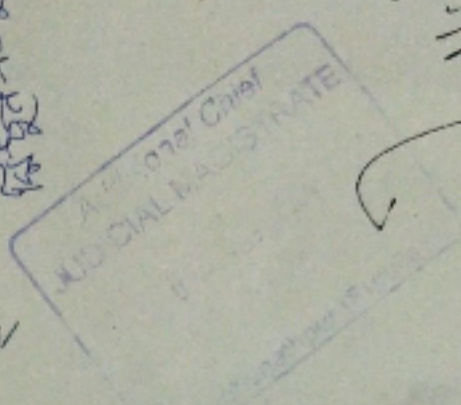
2. That frightend and disturb witness No.3 raised protest against such illegal act of Accd. persons from the roof of his house building in which Samar Bistu equivocally raised protest with his brother (i.e. witness No.3.) after coming out to Kuli Rasta in which Accused persons made pull and haul upon the person of Samar Bistu and seeing the same complainant rushed to his father to save his father at that time Mukteswar Rajwar and Bistu Rajwar attacked and assaulted the complainant with bleeding injury. Taking such advantage Accused persons Ashis havin armed with Axe and Debasish with Rod and Mukteswar with Lathi and Bistu trespassed into the house of Amar Bistu with an intention to cause griveous injury on the person of Amar Bistu by giving out threat to finish the life of Amar Bistu since he had raised voice against illegal act of the Accused persons however Amar Bistu him self from the clutches of accused persons .Complanents got treated at nearest Primary helth centre at Para owing to his injury inflicted by Accd. persons. Complainant informed the matter with Para P.S. in writting against accused person but in vain thereafter complain at sent his grievances to the S.P.Purulia thorough Regd. post on
