Accordingly I informed it to O/C Para PS and as per his instruction in between 15.35 hrs to 15.55 hrs I held raid in the house of accused Adhir Bauri (45yrs) S/o Lt- Jaladhar Bauri of Village- Jorberia, PS- Para, Dist- Purulia and found that the above noted person was selling Country Spirit contained in bottles named as "DIL KHUSH".
