I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Sri Goutam Modak S/O- Late Haradham Modak of Village- Jabarrah 1, P.O- Jhapra, P.S- Para, Dist- PURULIA has committed theft of Electricity U/S-135 (i) (b) of the Electricity (Amendment) Act-2007.

Entered the premises of Sri Goutam Modak, S.O- Late Haradham Modak of Village- Jabarrah, P.O- Jhapra, P.S- Para, Dist-Purulia and inspected his premises.

During inspection theft of Electricity was found, i.e. he/she was using Electricity dishonestly by means of direct tapping from the incoming side of service cable.

Supply i.e. U/S 135(i) (b) was detected.

From the above system he/she was using the following Electrical equipments i.e.

- (1) 2 fans of 100w each      (ii) 1 lamp of 100w  
Total = 300w.

Out of which we seized the following:

- (i) Energy Meter      (ii) By pass wire approximately 2m
