The humble petition of the complainant above name most respectfully beg to state that he is a permanent resident of his village within the jurisdiction of Purulia (M) police station on 19-05-2021 at about 10-10 a.m. the complainant was in his house. At that time due to previous grudge 1.sk Abul son of sk. yasin 2. Sk. Hafijul son of sk Yasin 3.Sk. Rahamat son of sk. yasin 4. Sk. Mustak son of Sk. Safik 5.sk. Arman son of Sk. safik all of village Kustuka, P.O. Hutmura, P.S. Purulia(M) District Purulia after forming an unlawful assembly and being armed with iron rod, Lathi, Tangi and Tabla reached near the house of the complainant and on threatening the complainant and others saying "Mar Salader-Kat Salader" illegally trespassed into the courtier and gheroud the complainant and with intent to kill the complainant, sk. Rahamat assaulted the complainant on his head by tabla and the complainant fell down with serious bleeding injury and become senseless then sk. Abul and sk. Hafijul assaulted Mahasin on his left hand by iron rod and when some of the witness tried to save the complainant then all the accused persons assaulted sk. Alauddin, sk. Iftikar and sk. Ruksad with fist, blows, kick and Lathi causing them injured then we raised hue and cry then some villagers came and saw and heard the incident then the assailants began to flee away but they tried to set fire into our residential house but could not do so they set fire on the heap of straw bundle which conflagrated causing our loss of rupees about 50,000/- (Fifty Thousand).

It is mentioned that sk. yasin son of sk. Safik and his son sk. Sarif son of sk. yasin were sentenced to suffer life imprisonment for later in a murder case and since sometime past they were being released on parole and they used to come to their house and again used to enter into the \mathcal{V} prison. Said two Convicted persons occasionally made threat to their relatives to assault the complainant and his other relatives. After the incident the injured persons at first were taken into kustaur health centre and the medical officer thereafter examining them referred to Purulia Sadar Hospital where the injured were admitted. After the incident, necessary complaint was lodged in purulia(M) police station who received the complaint but till 03-04-2021 did not started any case against the accused persons for which the complainant made an application along with the copy of the said complaint to the superintendent of police on 03-11-2021 but till now the superintendent of police has not taken any step on the complaint for which the complainant has filed this complaint before your Honour and prays that





the complaint may kindly be sent to the officer-in-charge of purulia (M) police station with direction to start a case on the basis of this complaint and to investigate and report. The complainant has no means to run the case out of his own means. The offence committed by the accused persons is cognizable and serious in nature.

And for which act of kindness the complainant shall ever pray.
