But suddenly some of them got violent and started to abuse our office staffs and attacked them physically, namely Mohan Das, Monsaram Mahato, Krishna Mahato. They also tried to destroy some official papers which was protected by our office staffs and with the help of police personnel.

Under this circumstance I would like to request you to take the strongest possible measures to book the culprits so that I can run the office peacefully.

This may be treated as FIR.
