Sub: Prayer for starting a specific case U/S- 285/286/188 IPC & Sec 24/26 of West Bengal Fire Service Act.

Sir,

In producing herewith one accused persons namely **Murari Lal Sharma (67 yrs) S/O- Lt. Shankar Lal Sharma of Kadamkuli, Ward No- 20, PS- Purulia(T), Dist.- Purulia** in custody, under proper memo of arrest in original, along with the following seized articles as per original seizure list that is (i) 04 packets of "Moon Flash" of Rajib Fireworks each containing 02 Pcs. (ii) 01 packet of "Green Move" of Rajib Fireworks each containing 02 Pcs. (iii) 400 packets of "Chut Putu" of Vadivel Pyrotechs each containing 10 Pcs. (iv) 16 packets of "Flower Pots Giant" of Bajrangi Fire Works Factory each containing 10 Pcs. (v) 04 packets of "Ground Chakkar" of Sri Kaliswari Fireworks Private Limited each containing 10 Pcs. (vi) 12 packets of "Super Light" of Ashok Fireworks Super Light each containing 10 Pcs. (vii) 02 packets of "Sushovan Fire Works" each containing 05 Pcs. (viii) 01 packet of " Flower Special" of Bajrangi Fireworks Factory each containing 10 Pcs. (ix) 09 packets of "Magic Wrinkle Sound" of POP each containing 50 Boxes (x) 40 packets of "Ashok Silver Tree" each containing 05 Pcs.

I beg to state that today on 03.11.2021 at 16:30 hrs received secret source information that a person has stored huge quantity of contraband high noise and air polluting fire crackers and fireworks at his shop namely Shankar Stores at Sandesh Gali Under Purulia(T) PS for selling those to the public, which have been banned from sell and purchase to public as per the order Dated 05.11.2020 of Hon'ble High court at Calcutta in c/w WPA No- 9184 and 9209 of 2020 and order Dated: 29.10.2021 in c/w WPA(P) 282 of 2021 with CAN 1 of 2021 with CAN 2 of 2021 in the matter of Roshan Ali vs State of West Bengal and others and in this respect West Bengal Pollution Control Board passed an order vide memo No. 329-21/WPB-F(V)/2021 dated 30.10.2021 for prohibiting the selling of firecrackers and its strict compliance.

Immediately I informed the matter to I/C Purulia(T) P.S as per the direction of I/C Purulia(T) P.S myself constituted a raiding party consisting of ASI Dibyendu Mahato, C/254 Karunamoy Bauri, C/942 Dipak Mukherjee left for Sandesh Gali under PS- Purulia(T) by Govt. vehicle which is diarized vide Purulia(T) PS GDE No- 144 dtd 03.11.21. After reaching near Sandesh Gali we left our vehicle there and proceeded on foot near the shop and at 16:55 hrs could notice that high noise and air polluting firecrackers and fireworks had been kept in the shop for selling those to the public so rashly and negligently which may endanger to human life, or may cause hurt or injury to any person. We apprehended one person in the shop Shankar Stores. On interrogation he disclosed his name as noted above and stated that he is the owner of the shop and had stored those banned fire crackers with a view to sell them to different buyers in exchange of money for his wrongful gain. On demand he could not produce any documents or permission for possessing or selling such high noise and air polluting firecrackers and fireworks and stated that he was acquainted about the fact that the sell and purchase of all type of firecrackers are banned this year as per the order of the Hon'ble High Court Calcutta.

So, there was a reasonable ground to believe that the above noted person was selling the articles i.e. contraband firecrackers and fireworks illegally without any proper license or permission endangering the human life near residential buildings which may likely to cause hurt or injury to any person without any proper guard which is sufficient against any probable danger to human life from the substance and have also violated the order of the Hon'ble High court.

Accordingly, I have seized aforesaid huge quantities of illegal firecrackers and fireworks under proper seizure list in between 17:10 hrs to 18:10 hrs duly signed by the witnesses and the accused person. As the subject had already tried to abscond to avoid legal proceedings and if not arrested he may abscond forever and his presence before the court whenever required could not be ensured hence I arrested him after conveying him the ground of arrest vide proper memo of arrest. The family member of the arrestee has been informed regarding arrest.

Under the above noted facts and circumstances, I am submitting a typed complaint against the accused person noted above with a request to start a specific case against him U/S 285/286/188 IPC & Sec 24/26 of West Bengal Fire Service Act and arrange for its investigation.
