


The above named Petitioner / Complainant Most respectfully begs to state as follows:

- That, the Complainant is a retired Home Guard under the Government of West Bengal and residing alone at his house at Munsiff Danga, Kulada Prasad Mukherjee Lane, within Purulia Municipality, Purulia Municipal Ward No. 02, P.O. - Purulia, P.S. - Purulia (Town), District - Purulia.
- 2. That, the Complainant retired from his service in the year 2010 but did not get any retirement benefit, gratuity or other benefits from




his service as per norms of the State Government Voluntary service and now has been passing days hand to mouth.

- 3. That, Smt. Namita Roy (Accused No.1) is the wife of Your Petitioner. Between the wedlock of Namita Roy and the Complainant one son and two daughters have been born namely Shantanu @ Babu Roy (Accused No. 3), and two daughters namely Mousumi @ Mou Roy (Accused No. 2) and Sonali Roy respectively.
- 4. That, the accused No. 4 namely Biswanath Roy @ Bablu Roy son of Late Haradhan Roy is the brother-in-law of the complainant, he along with his wife Gita Roy (Accused No. 5) always unwanted intervene with the family affairs of the Complainant and provoke the wife, son and daughters of the complaint against the complainant. Due to unwanted intervene by the Accused Nos. 4 and 5 into the family of the Complainant; the relationship of the Complaint with his wife, son and daughters has been deteriorated.
- 5. That, the younger daughter namely Sonali Roy has been given in marriage by the Complainant but at the instigation of her youngest maternal uncle namely Biswanath Roy @ Bablu Roy (Accused No. 3) son of Late Haradhan Roy, she has been residing at Jhalda, Purulia with her maternal uncle / Accused No.3, leaving her husband and her in-laws house. With the instigation of the accused nos. 4 and 5, Shantanu @ Babu Roy and Mousumi @ Mou Roy son and daughter of the Complainant left him and started residing with the Accused No. 4 at Jhalda, Purulia in the residence of the Accused No. 4.
 - 6. That, though the son and daughters of the complainant are well established, in spite of that at the instruction of the Accused No. 3, they do not take care and looking after their old, aged, ailing, partially paralyzed father the Complainant rather they left their father alone.



- 7. That, the complainant sustained a major brain stroke on 07.11.2020 for which he partially paralyze to his left side; but neither his wife nor any of his son and daughters came and looking after the complainant.
- 8. That, on 20.09.2021 morning while, the complainant went for his medical treatment after locking the door of his house, under lock and key; at that time at that time, Gita Roy wife of Biswanath @ Bablu Roy, Biswanath @ Bablu Roy son of Late Haradhan Roy, Namita Roy wife of the complainant, elder daughter of the Complainant namely Mousumi @ Mou Roy, son of the complainant namely Shantanu @ Babu Roy; all are now residing at "Maa Babar Aashirbad", Jhalda Main road, near Old Police Station, within Jhalda Municipality, Jhalda Municipal Ward No. 4, P.O. - Jhalda, P.S. - Jhalda, District - Purulia; with the active participation of some of neighbors of the complainant namely Bharati Mukherjee wife of Adwaity Mukherjee @ Lakkhi, their daughter Lovely Mukherjee, Meghna Sao wife of Biswajit Sao, their daughter Riya Sao, Pappu Sao son of Sunil Sao, Sunita Dutta wife of Subhas Dutta, Soma Bauri wife of Dinesh Bauri all are residents of Munsiffdanga, Kulada Prasad Mukherjee Lane, within Purulia Municipality, Purulia Municipal Ward No. 02, P.O. Purulia, P.S. Purulia (Town), District Purulia; enter into the house of the complainant by unlocking the door and steal the valuable articles viz. Cash, Gold Ornaments, other household articles including Ration Card, PAN Card, Bank Pass Book, Swastha Sathi Card, Registered Deed of House etc. of the Complainant. Another set of key of the house and Almirah of the complainant is also in the custody of Mousumi @ Mou Roy daughter of the Complainant, and by that set of key they open the door of house of the complainant.



- 9. That, after getting information of the incident from the witnesses named above, the Complainant lodged a Complainant on 21.09.2021 addressed to I.C. Purulia (Town) P.S. marrating the incident. But the I.C. Purulia (Town) P.S. did not take any initiative nor enquired the matter as such the Complainant waited for their return with the articles but they did not, as such the Complainant on 01.10.2021 lodged a complainant before the S.P. Purulia narrating the incident dated 20.09.2021 and the complaint dated 21.09.2021 address to I.C. Purulia Town P.S. but did not give the receive copy of the same to the Complainant, but up till now neither the Police of Purulia Town Police Station nor the S.P of Purulia did take any steps against the accused persons, for which the complainant compelled to file this case before Your Honour's.
 - 10. That, having no other alternative the Complainant knocks the door of the Learned Court of Law for his relief.
 - 11. That, it has been stated earlier that the Complainant /Petitioner is a retired, ailing person and now has been passing days hand to mouth as such he will not able to prosecute this case with his private capacity.

Hence the Petitioner/Complainant prays that Your Honour may graciously be pleased to send this Complaint to the I.C. of Purulia (T) P.S. with a direction to treat the same as F.I.R. and start a case against the accused persons. Otherwise there will be serious miscarriage of justice and the complainant will be seriously prejudiced.
