That after the said marriage, I came to know that, ~~he is a fake~~ IB Officer and married me by showing false and frivolous documents i.e. ~~he is not at all a Police Officer under the West Bengal Government or Government of India and he cheated with me by fraud documents.~~ When, I want to see his original documents regarding his service, ~~he started torture both physically and mentally.~~ Last of all I am compelled to leave to said house. In that connection, ~~I lodged a complain before the Superintendent of Police, Purulia on 29.09.2018.~~ I filed a Divorce but he is not traceable.
