Sub: Request for lodging F.I.R. against arrested accused person namely Bikash Sutradhar (24 yrs) s/o- Sushil Sutradhar of Napit Para, Garai Basti, Ward No- 17, PS- Purulia (T), Dist. Purulia.

Sir,

In producing herewith one arrested accused person namely Bikash Sutradhar (24 yrs) s/o- Sushil Sutradhar of Napit Para, Garai Basti, Ward No- 17, PS- Purulia (T), Dist. Purulia under arrest memo alongwith seized articles under proper seizure list and being labeled properly namely:-

- 1) 31 (Thirty one) bottles of Country Spirit designed as 'Dil Khush' (each bottle contains 300 ml of country spirit having strength 80° UP and MRP is Rs/- 25 being sealed properly) blended and bottled by Purulia Bottling Pvt. Ltd., Vill+ PO Lagda, Dist. Purulia, Pin 723149.
- 2) Out of 31 (Thirty one) bottles 01(one) bottle is kept as sample.

I, ASI Ujjal Rajak, beg to report that while I was performing 2nd Special mobile duty vide CC No. 3903/21 dtd. 26.11.21, at about 20.15 hrs at Napit Para received a secret telephonic information from source that one person namely Bikash Sutradhar (24 yrs) s/o- Sushil Sutradhar of Napit Para, Garai Basti, Ward No- 17, PS- Purulia (T), Dist. Purulia was selling country spirit at his house illegally at a higher price causing unlawful gain to him by unlawful loss to the purchasers.

Accordingly I informed the matter to I/C, Purulia (T) PS and after getting his permission myself alongwith my team consisting of NVF/0188 Arup Kr. Mahato and HG/333 Nakul Ch. Gorai all of Purulia (T) PS proceeded to work out the information. After sometime we reached at Napit Para keeping our Govt. vehicle at a reasonable distance we proceeded towards the house of Bikash Sutradhar near Napit Para, Garai Basti as shown by the source from the distance and found that the said person was selling Country Spirit as noted above to some persons inside his house and some persons were found drinking there. Seeing the police, all of them tried to flee away leaving some plastic glasses at the spot. On hot chase one of them could be nabbed. On interrogation the said person disclosed his identity as noted above. On search of the house we found 31 (Thirty one) bottles of Country Spirit designed as 'Dil Khush' (each bottle contains 300 ml of country spirit having strength 80° UP) blended and bottled by Purulia Bottling Pvt. Ltd., Vill+ PO Lagda, Dist. Purulia, Pin 723149. On further interrogation Bikash Sutradhar stated that the said place is his house and was selling Country Spirit as noted above to the locals without having any authority at a higher price since long. He also failed to produce any license in favour of selling, keeping or possessing Country Spirit. As such at about 20.35 hrs to 20.55 hrs I seized the above noted Country Spirit under proper seizure list in presence of witnesses after labeling and sealing properly. I also took samples and arrested him observing all the formalities as the said person committed an offence which attracts sec. 46 (A) (C) of B.E. Act 1909.

Hence, I pray before you to start a specific case against the above noted person under proper section of law and kindly arrange for its investigation.
