Sub: Prayer for starting a specific case against arrested accd. Debranjan Haldar (40) S/o Istaranjan Haldar of Natunbazar, Ward No 3, PS - Raghunathpur, Dist.- Purulia.

Sir.

In producing herewith arrested accd Debranjan Haldar (40) S/o Istaranjan Haldar of Natunbazar. Ward No 3, PS - Raghunathpur, Dist.- Purulia with arrest Memo, along with seized articles viz (1) 40 packets of Crackers designed as Dulal Chocolate, each packet contains 10 pcs of crackers ,Total (40 x 10) =400. (2) 10 packets of Crackers designed as Black cat Chocolate, each packet contains 10 pcs of crackers Total (10 x 10) =100 and (3) 10 packets of Crackers designed as Dulal Special Chocolate, each packet contains 10 pcs of crackers , Total (10 x 10) = 100, under proper seizure list, I ASI Khudiram Bouri of Raghunathpur PS, beg to report that, on 03.11.2021 during my evening mobile duty received a telephonic information from my source that one person is selling crackers illegally in his shop. Accordingly I informed the matter to I/C Raghunathpur PS and as per his direction myself along with C/682 Mahadeb Rajak, C/536 Astik Bauri and C/1517 Tinkari Chakraborty, started for working out the information Raghunathpur PS C.C. No 2728/21 dated- 03.11.2021 and briefing them carefully about the information and my plan to catch him red handed. We reached at Natunbazar, Ward No 3 on 03.11.21 at 20:35 hrs. and proceeded to the spot on feet and as per public information identified the stationary shop styled as "SEVA BHANDAR". We entered into the shop and seeing police personnel 2/3 persons fled away from the shop 'and we detained one person who on asked revealed himself as Debranjan Haldar (40) S/o Istaranjan Haldar of Naturbazar, Ward No 3, PS - Raghunathpur, Dist.- Purulia and identified himself as the owner of the shop and when I told him about the information, he fully confessed that he used to sell crackers and on searching the shop recovered (1) 40 packets of Crackers designed as Dulal Chocolate, each packet contains 10 pcs of crackers .Total (40 x 10) =400, (2) 10 packets of Crackers designed as Black cat Chocolate, each packet contains 10 pcs of crackers, Total (10 x 10) =100 and (3) 10 packets of Crackers designed as Dulal Special Chocolate, each packet contains 10 pcs of crackers, Total (10 x 10) = 100 and on being demanded he failed to produced any license or constitutional papers in favour of keeping, storing or selling any crackers or combustible or fire articles and also confessed that inspite of knowing it fully well that it is strictly illegal and unlawful to sell, keep or store, he had been selling those crackers after having a huge store of it in the shop from the past few days. Accordingly I seized the above mentioned fire crackers from his exclusive possession after furnishing proper seizure list and arrested him accordingly for his negligent conduct with respect to fire or combustible or explosive substances which can endangered human life. It is worthy enough to be noted that no public witness found in that dead night and hence the seizure was done under the presence of my accompanying forces. I would like to note here that though the punishment of the offence he has committed is less than 07 years yet I arrested him because he may temper the evidences.

Hence I pray that a specific case may kindly be started against above noted arrested accused. person under proper section of law and arrange for its investigation.
