Respected Sir,

With due respect and humble submission, I beg to state that on 03.11.21 at 12.55 hrs SI Tapan Tewary received an information from his source that a huge number of fire crackers have been sold by Pradip Kora S/O- Mahananda Kora of vill-Chowkbadh PS-Santaldih , Dist – Purulia at his shop near Chowkbad more under this PS. He diarized the matter vide Santaldih PS GDE no-125 dtd-03/11/21 and informed the matter to I.C Santaldih P.S and as per order of IC Santaldih PS he had been to the above noted place with ASI Subhash Mahato, Constable-3246-Buddhadeb Ruidas, JC/1393 Ramjan Ansary at 13.15 hrs. He parked the vehicle in a reasonable distance and cordoned the above noted shop by P.S. force. He detained 01 person and on asked he disclosed his identity noted above and identified himself as the owner of the above noted shop. He searched the shop of above noted Pradip Kora in presence of local disinterested witnesses and seized 1) 08(eight) packets of fire crackers containing 10 Pcs each, styled as 'INDIGO HYDRO' 2) 05 (five) packets of Bizili Crackers containing 100 Pcs each, styled as 'SAI BALAJI FIRE WORKS, SIVAKASI' with proper seizure list. He asked him to produce relevant documents regarding the said crackers but he failed to produce in favour of keeping, storing or selling of such combustible or fire articles. On asked he also confessed his guilt regarding committing of offence. Accordingly, He arrested said Pradip Kora observing all arresting guidelines and brought him to PS. Over this started Santaldih PS Case No 75/21 dtd- 03.11.2021 U/S- 188 IPC and 24 The West Bengal Fire Services Act, 1950 and as per endorsement I, SI Sujit Kr. Majhi took up its investigation.

During investigation, the above noted arrested accused person stood surety for obtaining Bail and as per order released him on bail after taking proper bail bond & PR bond.

So, I, therefore, pray, before your kind honour that the Bail bond & P.R. bond may kindly be accepted and approved the same.
