Sub:- Prayer for lodging FIR .

Respected Sir,

In producing herewith 02 (two) arrested accused persons (1) Bikram Banerjee (21), S/O Kanti Gopal Banerjee of Kankibasti and (2) Aslam Ansary (46), S/O Md. Anwar Ansary of Kankibazar, both of PS-Santaldih , Dist – Purulia along with seized articles (i) 04 (Four) packets of 02 sound fire crackers containing 05 (Five) Pcs each, styled as ' LILLY BRAND' & 11 (Eleven) packets of Bijili fire Crackers containing 100 (Hundred) Pcs each, styled as 'ARYA PANDA' and (ii) 06 (Six) packets of 02 sound fire crackers containing 05 (Five) Pcs each, styled as 'LILLY BRAND' & 10 (Ten) packets of Bijili fire Crackers containing 100 (Hundred) Pcs each, styled as 'COCK BRAND' with proper seizure list I beg to submit that on 04.11.21 at 18.05 hrs received an information from my source that a huge number of fire crackers have been sold by above noted persons at STPS 1 No. gate under this PS. I diarized the matter vide Santaldih PS GDE no. 168 dtd- 04/11/21 and informed the matter to you and as per your kind order had been to above noted place with C/1221 Yudhistir Kumar, C/1376 Tapan Das and C/277 Prabir Mandal at 18.15 hrs. I parked the vehicle in a reasonable distance and cordoned the shop of above noted Bikram Banerjee and Aslam Ansary by P.S. force. I detained them and on asked they disclosed their identity noted above and identified themselves as the owner of the above noted shops. I searched the shops of above noted persons in presence of local disinterested witnesses and seized the above noted fire crackers having Sl. No. (i) of seized articles from above noted Bikram Banerjee and Sl no. (ii) from above noted Aslam Ansary with proper seizure list duly signed by witnesses. I asked them to produce relevant documents regarding the said crackers but they failed to produce in favour of keeping, storing or selling of such combustible or fire articles. On asked they also confessed their guilt regarding committing of offence. Accordingly, I arrested them observing all arresting guidelines.

It is noted here that Honble High Court Calcutta passed an order in WPA (P) 282 OF 2021 Dtd 29.10.21 regarding prohibition of selling of firecrackers and in this respect West Bengal Pollution Control Board passed an order vide Memo no 329 -21/WPB-F(V)/2021 Dated-30/10/21 for prohibiting the selling of fire crackers and its strict compliance.

Hence I pray before you to start a case in this respect under proper section of law and arrange its investigation.
