In producing herewith arrested accused persons (1) Jogesh Mahato (25), S/O Mahadev Mahato of Deoli, (2) Rahul Mahato (18), S/O Hiralal Mahato of Kankibazar, (3) Bidyut Mahato (30), S/O Dilip Kr Mahato of Chakbad, (4) Susanta Ghosh (27), S/O Nihar Ranjan Ghosh of Nabagram, (5) Akash Rajak (25), S/O Kinkar Rajak of Nabagram and (6) Hiralal Roy (30), S/O Bijoy Roy of Nabagram, all of PS - Santaldih, Dist. - Purulia. I, SI Subrata Sadhu of Santaldih PS do hereby lodge complaint that today (26.11.2021) at 19:05 hrs, when myself along with force were engaged in mobile duty at PS area and found the above noted persons were moving in front of STPS Township gate no. 1 under Santaldih PS, without wearing Mask or any face guard, as such I detained them on that spot. On being asked the above noted persons could not able to give any satisfactory answer for not wearing Mask / face guard in this pandemic situation. As such the above noted persons violated the order during the pandemic situation duly promulgated by Govt. of WB in c/w Corona virus/Covid-19 vide order no. 753/III-ISS/2M-22/2020, Dated 14.07.2021. Moreover, all the detained persons were making and circulating false alarm or warning as to disaster or its severity or magnitude, leading to panic among people and as well as the society. Accordingly, the above noted persons were arrested after maintaining all the formalities regarding arrest and brought them to PS.
