Respected Sir,

In producing herewith 01 (one) accd person Bhajen Mondal (Age 41Yrs) S/O-Aniruddha Mondal of Vill- Santuri, PS-Santuri, Dist - Purulia along with seized articles 1) 25(Twenty five) packets of Bizili crackers containing 100 Pcs each, styled as PANDA BIJILI CRACKERS' 2) 04 (Four) packets of Bizili Crackers containing 100 Pcs each, styled as 'S.G.H Jai Manoj Turkey Bijili' 3) 01(One) packets of fire crackers containing 10 Pcs each, styled as 'BLACK CAT CHOCOLATE BOMB' 4) 50 (Fifty) Pcs. Loose chocolate bombs in a plastic packet with proper seizure list I beg to submit that today on 03.11.21 at hrs received an information from my source that a huge number of fire crackers have been sold by above noted person at his shop near Santuri More, under this PS. I diarized the matter vide Santuri PS GDE no- 96 dtd-03/11/21 and informed the matter to you and as per your kind order had been to the above noted place with C/702- Anal Kanti Banerjee, C/1154- Jagannath Jha. I parked the vehicle in a reasonable distance and cordoned the above noted shop by force. I detained 01 person and on asked he disclosed his identity noted above and identified himself as the owner of the above noted shop. I searched the shop of above noted Bhajen Mondal in presence of local disinterested witnesses and seized the above noted fire crackers from his shop. I asked him to produce relevant documents regarding the said crackers but he failed to produce in favour of keeping, storing or selling of such combustible or fire articles. On asked he also confessed his guilt regarding committing of offence.

It is noted here that Honble High Court Calcutta passed an order in WPA (P) 282 OF 2021 Dtd 29.10.21 regarding prohibition of selling of firecrackers and in this respect West Bengal Pollution Control Board passed an order vide Memo no 329 -21/WPB-F(V)/2021 Dated-30/10/21 for prohibiting the selling of fire crackers and its strict compliance.

Hence I pray before you to start a case in this respect under proper section of law and arrange its investigation.
