

Sub: Prayer for lodging FIR.

Sir.

In producing herewith the arrested accused person namely Lalmohan Mahato (31 Yrs) S/O- Chandrakishore Mahato of Vill- Kumargara, P.O- Palma Pechara, PS- Kenda, Dist-Purulia, along with Memo of arrest, seizure list & seized articles (i) 12 packets of Crackers designed as Rolex Chocolate, each packet contains 12 pcs of crackers, Total (12x12)= 144. (ii) 12 packets of Crackers designed as MAHAVIR'S (BAJRANGI) CHOCKLETE BOMB, each packet contains 12 pcs of crackers, Total (12x12)= 144. (iii) 03 packets of Crackers designed as CHUT PUTU, each packet contains 10 pcs of crackers. Total (03x10)= 30. (iv) 10 packets of Crackers designed as WIN 2 sound, each packet contains 05 pcs of crackers, Total (10x05) 50. I beg to submit that on 03.11.2021 as per source information & direction of O.C Lamna PS; myself along with SI Badal Paramanik and force had been to Bhadsa more under Tamna PS to work out the information regarding selling of fire crackers.

Accordingly, myself along with SI Badal Paramanik and force namely C/- 610 Achinta Bouri, C/- 1139 Jiban Senapati & C/1021 Lakshmi Kanta Bauri with Govt, vehicle bearing registration No- WB 36L 5832 reached at Bhadsa more under Tamna PS at 18:30 hrs and found that one person is selling and dealing with fire crackers (Prohibited articles) and seen the Police party tried to fled away. Somehow we managed to apprehend him and on being asked his identity, he disclosed his identity as Lalmohan Mahato (31 Yrs) S/O- Chandrakishore Mahato of Vill- Kumargara, P.O- Palma Pechara, PS- Kenda, Dist-Purulia, Lasked him to produce valid paper/license in respect of selling/ keeping/dealing with fire crackers (prohibited articles). He failed to produce any papers or license and cannot gives any satisfactory answer and confesses his guilt.

Accordingly, I seized (i) 12 packets of Crackers designed as Rolex Chocolate, each packet contains 12 pes of crackers, Total (12x12)= 144. (ii) 12 packets of Crackers designed as MAHAVIR'S (BAJRANGI) CHOCKLETE BOMB, each packet contains 12 pes of crackers, Total (12x12)= 144. (iii) 03 packets of Crackers designed as CHUT PUTU, each packet contains 10 pes of crackers. Total (03x10)= 30. (iv) 10 packets of Crackers designed as WIN 2 sound, each packet contains 05 pes of crackers, Total (10x05)=50. I marked the Alamat as Exhibit- A; from the possession of the above noted accused person. The seizure list was prepared at P.O and duly signed by detained persons and witnesses. After that I arrested him by issufing memo of arrest. Then myself along with force, seized articles and all relevant papers and accused persons left for PS

On arrival at PS I prepared this letter of complaint and handed over everything to O.C Tamna through Duty officer for starting a case under proper section of law against the accused persons.
