I, SI Hemanta Kr. Sahababu, S/O- Lt. Madan Mohan Sahababu of Tamna PS. Dist-Purulia, do hereby produce (1) Santosh Mahato (35 Yrs), S/O- Lt. Kalipada Mahato. (2) Ramesh Mahato (40 Yrs), S/O- Anil Mahato, (3) Dipak Mahato (36 Yrs) S/O- Kiriti Mahato, (4) Lambodhar Majhi (42 Yrs), S/O- Labu Majhi, all are of Vill- Misirdih, P.O- Pundru, PS- Tamna, Dist-Purulia, and lodge a written complaint against them, to the effect that on 08.11.2021 while myself along with force of Tamna PS as per direction engaged in PS Spl. Kalipada Mahato, (2) Ramesh Mahato (40 Yrs), S/O- Anil Mahato, (3) Dipak Mahato (36 Yrs) S/O- Kiriti Mahato, (4) Lambodhar Majhi (42 Yrs), S/O- Labu Majhi, all are of Vill- Misirdih, P.O- Pundru, PS- Tamna, Dist- Purulia under proper section of law as they ignored the norms of Govt. of India as well as Govt. of West Bengal and committed negligent Act. likely to spread infection of diseases dangerous to life and arranged for its investigation.
