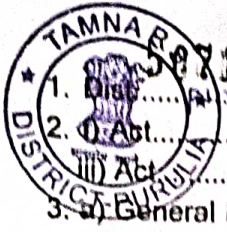

Respected Sir,

In producing herewith one arrested accused person namely Pasupati Majhi (50 yrs) S/O- Lt. Nagendra Majhi of Village - Gopladih, P.S- Tamna, Dist.- Purulia with seizure list and seized articles, I beg to submit that today i.e. on 26.11.2021 at about 06.05 hrs during special mobile duty, received a secret source information and as per order of OC Tamna PS, ISI Bikash Chandra Patra of Tamna PS along with force had been to Gopladih village under Tamna PS at 06:25 hrs and as per indication conducted raid in the house of Pasupati Majhi (50 yrs) S/O- Lt. Nagendra Majhi of Village - Gopladih, P.S- Tamna, Dist.- Purulia and found 2/3 persons fled away from his house and detained one person. On asking he disclosed his identity as noted above. On interrogation he confessed his guilt for selling and possession of Cholai mod. On demand he failed to produce any valid documents in respect of stock and selling of said Cholai mod at his own house. As such I seized (i) (i) TINTI (03) SADA RONGER PLASTIKER JARIKEN JAHAR MODIYE 05 (FIVE) LITER KORE CHOLAI MOD ACHHE (ii) EKTI SABUJ RONGER PLASTIKER BOTTLE JAHAR MODIYE 02 (TWO) LITER CHOLAI MOD ACHHE. under proper Seizure List in presence of witnesses and signed by witnesses as well as accused person and arrested the above noted accused person namely Pasupati Majhi (50 yrs) S/O- Lt. Nagendra Majhi of Village - Gopladih, P.S- Tamna, Dist.- Purulia after observing all legal formalities regarding arrest. Informed him the ground of his arrest. The seized articles were properly sealed and label in presence of witnesses duly signed by them and accused person.

The above noted accused person namely Pasupati Majhi (50 yrs) S/O- Lt. Nagendra Majhi of Village - Gopladih, P.S- Tamna, Dist.- Purulia committed offence u/s- 46 A(c) B.E. Act- 1909 for unauthorized possession and sales of ID Liquor from his house.

Under the fact and circumstances kindly take necessary lawful action against Pasupati Majhi (50 yrs) S/O- Lt. Nagendra Majhi of Village - Gopladih, P.S- Tamna, Dist.- Purulia.
