I Sri Prashant Kishor, S/O - Kishori Prasad, A.E. & Station Manager of Telkalpara CCC of WBSEDCL do hereby lodge my complaint empowered by the Electricity (Amendment) Act-2007 to the effect that Nripen Kumar S/O Sraban Kumar of Vill - Kotloi PS- Tamna has committed theft of electricity under section 135(1)(b) as detailed here under.

Today, i.e. on 26.11.2021 I, Prashant Kishor (AE&SM), along with Sri Suraj Kumbhakar, JE (Gr-ii), Sri Deb dulal Banerjee, Sr. TSH of Telkalpara CCC, WBSEDCL conducted a raid programme at village Kotloi under Tamna P.S. When our team at about 12.20 P.M. entered to the Domestic premises of Nripen Kumar, we found that he was enjoying electricity dishonestly by means of Meter bypass by tampering service cable and run Domestic appliances, thus WBSEDCL losses revenue. As theft of electricity was detected in presence of the local witnesses, service cable with bypass arrangement dismantled and seized and seizure list prepared. The seized material labeled in presence of the local witnesses. The inspection team left the aforesaid location at about 12.40 P.M. after completion of inspection & necessary formalities.

Nripen Kumar S/O Sraban Kumar of Vill - Kotloi, PS- Tamna has committed theft of electricity under section 135(1)(b) of the Electricity (Amendment) Act-2007.
