Respected Sir,

In producing herewith one arrested accused person namely Amir Mahato (32 yrs) S/O- Kamal Mahato of Village - Baligara, P.O.- Baligara, P.S- Tamna, Dist - Purulia with seizure list and seized articles, I beg to submit that today i.e. on 26.11.2021 at about 18.05 hrs during special mobile duty, received a secret source information and as per order of D.C Tamna PS, I ASI Gopal Hembram of Tamna PS along with force had been to Baligara village under Tamna PS at 18:35 hrs and as per indication conducted raid in the house of Amir Mahato (32 yrs) S/O- Kamal Mahato of Village - Baligara, P.O.- Baligara, P.S- Tamna, Dist - Purulia and found 2/3 persons fled away from his house and detained one person. On asking he disclosed his identity as noted above. On interrogation he confessed his guilt for selling and possession of Cholai mod. On demand he failed to produce any valid documents in respect of stock and selling of said Cholai mod at his own house. As such I seized three (03) plastic jerrican each containing four (04) liters of ID Liquor, total approx 12 liters under proper Seizure List in presence of witnesses and signed by witnesses as well as accused person and arrested the above noted accused person namely Amir Mahato (32 yrs) S/O- Kamal Mahato of Village - Baligara, P.O.- Baligara, P.S- Tamna, Dist.- Purulia after observing all legal formalities regarding arrest. Informed him the ground of his arrest. The seized articles were properly sealed and label in presence of witnesses duly signed by them and accused person

The above noted accused person namely Amir Mahato (32 yrs) S/O- Kamal Mahato of Village - Baligara, P.O.- Baligara, P.S- Tamna, Dist.- Purulia committed offence u/s- 46 Act B.E. Act- 1909 for unauthorized possession and sales of ID Liquor from his house

Under the fact and circumstances kindly take necessary lawful action against Amir Mahato (32 yrs) S/O- Kamal Mahato of Village - Baligara, P.O.- Baligara, P.S- Tamna, Dist - Purulia.
