Sir,

In producing herewith arrested accused person namely Sanjoy Bauri (27 Yr S/O Bhakti Bauri of Vill-Mandapdanga, P.O- Moutore, PS-Raghunathpur, Dis Purulia along with seized articles (1) One Motor cycle, Black colour Bajaj Puls bearing Reg. No-WB 82C/3210 (2) One driving license in the name of Sanjoy Bauri vide D/L No-KA0120200032036.

I beg to report that today myself along with C/122 Rabindra Kr Verma at C/1252 Sunil Kr Mandol both of Adra PS were performing Evening mobile duty Kharai village more under Adra PS area vide Adra PS C.C No-4157/21 dtd.30.11.2021 and Adra PS GDE No-1112. At about 20:15 hrs, I found one motor Cycle bearing Reg No- WB 82C/3210 coming from Kashipur side rashly and negligently. We try to stop him but the rider of the said motorcycle named in above was trying to escape the place so rashly, there was every possibility of loss/ serious injury of nearby public due to his such riding. After a hot chase we could not stop him. On being asked, he stated his name and address as noted above, but unable to give any satisfactory account for his such rush and negligent driving which may cause endanger to human life.

So, I arrested him as he violated sec 279 IPC at about 20:55 hrs. I also seized the motor cycle and his driving license with a view to prosecute him U/S 279 IPC in the presence of police party. As the place is lonely so there is no public present at that time. The whole process of seizure was completed in between 20:35 hrs to 20:55 hrs. His family member was also informed about the ground of arrest.

Hence I pray that a specific case U/S 279 IPC may kindly be initiated against accused Sanjoy Bauri (27 Yrs) S/O Bhakti Bauri of Vill-Mandapdanga, P.O Moutore, PS-Raghunathpur, Dist- Purulia.
