Sir,
In producing herewith arrested accused person namely Subhadip Dey (22 Yrs) S/O Kanu Dey of Vill-Palashbon, P.O- Baktarnagar, PS-Andal, Dist- Paschim Bardhaman along with seized vehicle (1) One white colour TATA Ace vide registration no-WB 39B 5124.

I beg to report that today myself along with C/571 Hasib Khan and C/424 Naba Kr Sao both of Adra PS were performing night mobile duty at Adra Raghunathpur road under Adra PS area vide Adra PS C.C No-4159/21 dtd.30.11.2021 and Adra PS GDE No-1128. At about 22:45 hrs, I found one TATA Ace bearing Reg. No- WB 39B 5124 standing on the portion of Adra Raghunathpur pitch road at a sharp turning near Jhankai srenei kali mandir. As the time is night hours and also due to foggy atmosphere the visibility is also not clear so due to this illegally parked vehicle there was every possibility of loss/ serious injury of other vehicle's driver/passenger. On search it is found that the driver is taking rest and he also has the knowledge to park the said vehicle illegally. On interrogation he disclosed his identity but could not able to give any satisfactory answer regarding this illegal parking. On asked he al failed to produce his driving license.

So, I arrested him as he violated sec 283 IPC & 122/177/181 MV Act 1988 at about 23:15 hrs. I also seized the motor cycle and his driving license with a view to prosecute him U/S 283 IPC & 122/177/181 MV Act 1988 in presence of police party. As the place is lonely so there is no public present at that time. The whole process of seizure was completed in between 22:55 hrs to 23:15 hrs. His family member was also informed about the ground of arrest.

Hence I pray that a specific case U/S 283 IPC & 122/177/181 MV Act 1988 may kindly be initiated against accused Subhadip Dey (22 Yrs) S/O Kanu Dey of Vill-Palashbon, P.O- Baktarnagar, PS-Andal, Dist- Paschim Bardhaman.
