Sir,

In producing herewith arrested accused person namely Prasanta Bauri (32 Yrs) S/O Subodh Bauri of Vill-Kharai (Susunidih), PS-Adra, Dist- Purulia along with seized articles (1) One maroon colour Honda CB Shine-125 Optimax Motorcycle, bearing Reg. No-WB56G/1689.

I beg to report that today myself along with C/100 Sukumar Jana and C/1272 Bikash Chandra Patra both of Adra PS were performing special mobile duty at Kali More, North Town Beat under Adra PS vide Adra PS C.C No-4372/21 dtd.22.12.2021 and Adra PS GDE No-922. At about 17:15 hrs, I found one maroon colour Honda CB Shine Motorcycle coming from Raghunathpur side towards Kashipur side rashly and negligently. We try to stop him but the rider of the said motorcycle named in above was trying to escape the place so rashly, there was every possibility of loss/ serious injury of nearby public due to his such riding. After a hot chase we could able to stop him. On being asked, he stated his name and address as noted above, but unable to give any satisfactory account for his such rush and negligent driving which may cause endanger to human life.

So, I arrested him as he violated sec 279 IPC and 184 MV Act 1988 at about 17:55 hrs. I also seized the motor cycle with a view to prosecute him U/S 279 IPC and 184 MV Act 1988 in presence of police party. As the place is lonely so there is no public present at that time. The whole process of seizure was completed in between 17:35 hrs to 17:55 hrs. His family member was also informed about the ground of arrest.

Hence I pray that a specific case U/S 279 IPC and 184 MV Act 1988 may kindly be initiated against accused Prasanta Bauri (32 Yrs) S/O Subodh Bauri of Vill-Kharai (Susunidih), PS-Adra, Dist- Purulia.
