In producing herewith one arrested person namely Madhab Kumar Bauri (26 yrs) S/O Lt. Narayan Bauri of Vill-Sanga Mahul, PO-Mugma, PS – Nirsha, Dist- Dhanbad (JKD) along with seized 02 Mobile phone 1.One Blue colour Realme-5 mobile Phone vide IMEI No-i.862926046193994 ii. 862926046193986 2. One Blue Colour Redmi Note 9 Pro Max Mobile phone vide IMEI No-i.868448047980992, ii. 868448047981008 and One Red and Black colour Passion plus Motor Cycle vide Reg. No-JH10S/2521 seized under proper seizure list, memo of arrest and inspection Memo in respect of the supra person before you.

The nub of the fact in a nutshell is that today 11.12.2021while I along with force namely 1) C/568 Madhusudan Rajower 2) C/2312 Rajendranath Bera left the PS for performing Evening petrol duty vide CC No 4289/21 Dated 11.12.2021 and Adra PS GDE no 468 Dated 11.12.2021 in PS area. During my petrol duty, I received a tip off at 18:45 hrs that a mobile thief is moving suspiciously at Ram Mandir More Adra. After informing I/C Adra PS I along with force went to Ram Mandir More Adra at 19.05 hrs. As per identification of source I found that one person moving suspiciously at Ram Mandir More Adra in a Red &Black Passion Plus motorcycle. At the sight of Police said person took to his heels and after a chase he was caught hold. On interrogation he disclosed his name as stated above. I asked the nearby shop owner and the passerby to become witness of the procedure and following 02 persons agreed to stand as witnesses (1) Md. Imtyaz S/O Md. Nasim of Vill- Lower Jhariadih, PS-Adra, Dist- Purulia (2) Ayan Tantubai S/O Sankar Tantubai of Vill-Kamlasthan, PS-Adra, Dist- Purulia. Then I offered the said Madhab Kumar Bauri to search me and my Police party before searching his body, but he refused. Then I searched his body and found 02 Mobile phone 1.One Blue colour Realme-5 mobile Phone vide IMEI No-i.862926046193994 ii. 862926046193986 2. One Blue Colour Redmi Note 9 Pro Max Mobile phone vide IMEI Noi.868448047980992, ii. 868448047981008. I demanded for relevant document from him in respect of said 02 Mobile Phones and Motorcycle which are in his possession but he failed to produce any such documents in respect of the said 02 mobile phones and Motorcycle and could not give any satisfactory account in this regard which made him to believe that the accused person theft / received these 02 Mobile Phone and motorcycle in an illegal manner. So I seized said 02 Mobile Phone and Motorcycle from the exclusive possession of accused Madhab Kumar Bauri under proper seizure list duly signed by Police witnesses and also by the accused person. I prepared label for the seized item and I took signature of accompanied force in the seizure list and label. After that I arrest the above noted accused person observing all the rules and guide lines of apex court and NHRC. The whole process was done in between 19.25 hrs and 19.55 hrs after arrest it was found that accused has some old bodily injuries and he was medically checked up at Kolloli BPHC, Kashipur.

As he illegally theft/received and possessed above noted 02 Mobile Phone and Motorcycle to use those for unlawful purpose. So, after returning at PS, I produced the arrested accused along with the seized 02 Mobile Phones and Motorcycle with all relevant documents before you.

Under the above circumstances, I therefore pray that a case may kindly be started under proper sections of law against the arrested accused person Madhab Kumar Bauri (26 yrs) S/O Lt. Narayan Bauri of Vill-Sanga Mahul, PO-Mugma, PS – Nirsha, Dist- Dhanbad (JKD) and to arrange for its investigation.
