Sir, In producing herewith arrested accused person namely Bibek Mahato (20 Yrs) S/O Vaktipada Mahato of Vill-Raherdih, PO-Dubra, PS-Para, Dist- Purulia along with seized articles (1) One white colour Apache RTR-160 new Motorcycle, bearing Eng. No-AE8GM2704136 & Chassis No- MD634AE81M2604118.

I beg to report that today myself along with C/140 Subrata Banerjee and NVF/903 Giridhari Mahato both of Adra PS were performing evening mobile duty at Wireless Maidan more on Adra Kashipur road under Adra PS area vide Adra PS C.C No-4295 21 dtd.12.12.2021 and Adra PS GDE No-508. At about 19:15 hrs, I found One white colour Apache RTR-160 new Motorcycle coming from Adra side towards Kashipur side rashly and negligently. We try to stop him but the rider of the said motorcycle named in above was trying to escape the place so rashly, there was every possibility of loss/serious injury of nearby public due to his such riding. After a hot chase we could able to stop him. On being asked, he stated his name and address as noted above, but unable to give any satisfactory account for his such rush and negligent driving which may cause endanger to human life. On demand he also failed to produce any driving license.

So, I arrested him as he violated sec 279 IPC and 181/184 MV Act 1988 at about 19:55 hrs. I also seized the motor cycle with a view to prosecute him U/S 279 IPC and 181/184 MV Act 1988 in presence of police party. As the place is lonely so there is no public present at that time. The whole process of seizure was completed in between 19:35 hrs to 19:55 hrs. His family member was also informed about the ground of arrest.

Hence I pray that a specific case U/S 279 IPC and 181/184 MV Act 1988 may kindly be initiated against accused Bibek Mahato (20 Yrs) S/O Vaktipada Mahato of Vill-Raherdih, PO-Dubra, PS-Para, Dist- Purulia.
