Sir,

In producing herewith seized 03 scooters along with total 15 sacks of coal total weight about 4.5 quintal and 05(five) arrested accused persons namely 1) Sudan Gorai (26) S/O- Badal Gorai (Rider of one steel colour old scooter loaded with 05 sacks Coal weight about 1.5 quental). 2) Radha Charan Gorai (24) S/O- Nirmal Gorai (Rider of one blue & chocolate colour old scooter loaded with 05 sacks Coal weight about 1.5 quental) both of Vill- Sutaboi, PS-Kashipur, Dist- Purulia 3) Intaj Ansari (31) S/O- Safu Ansari (Rider of one steel colour scooter loaded with 05 sacks Coal weight about 1.5 quental) (4) Noor Mohammad Ansari (33) S/O- Safu Ansari (Pillion Rider of Scooter noted in SI no 1) both of Vill-Jamkuri, PS-Kashipur, Dist-Purulia, 5) Sayed Ansari(32) S/O- Rashid Ansari (Pillion Rider of Scooter noted in SI no-2) of Vill- Kuldih, PS- Kashipur, Dist- Purulia along with seized articles and all connected papers. Noted that Registration Number, engine Number, chassis Number are not found in all the above noted 03 scooters.

I, beg to submit that, I SI Ashoke Kumar Mahata along with C/122 Rabindra Kumar Verma, C/568 Madhu Sudan Rajower all of Adra PS vide Adra PS CC No-4352/21 dtd.18.12.2021 while performing day mobile duty at 12:45 hrs received a credible source information that some persons are transporting coal by their Motorecycle towards Metyalsahar village through Metyalsar-Raghnathpur pitch road which has been procured by means of theft or any fraudulent manner. After receiving the said information we have started to move towards Metyalsahar High School More on that road under our P.S. jurisdiction with a view to intercept the said vehicles. At about 13:25 hrs we found some scooters, loaded with coal in plastic sack are coming from Chorpahari side. Seeing the police party all the riders and pillion riders of the said 03 scooters left their scooters on road and started to fled away. However after a small chase we could able to apprehend all the above noted 05 persons. On being demand all the apprehend persons failed to produce any valid document in respect of the procured coal as well as their scooters. On verification it is reasonable to believe that the rider's and pillion rider's of the above noted scooters collected coal either theft or any illegal means and transporting to run clandestine business for wrongful gain and they are engaged, in winning or mining coal from the whole or part of any land in respect of which no valid prospecting license or mining lease or sub-lease is in force. So, I seized said 03 scooters along with total 15 sacks of coal total weight about 4.5 quintal under proper seizure list and arrested all the above noted accused persons. There was no such public witness came forwarded after requesting at that time to stand as witness of seizure, so I seized all the items as mentioned in seizure list in presence and signed by police party. The whole process was done in between 13.35 hrs to 13.55 hrs. Thereafter I brought the seized 03 scooters along with 15 sacks of coal total weight about 4.5 quintal at Adra PS compound.

I, therefore pray before you to lodge a specific case against (1) Sudan Gorai (26) S/O- Badal Gorai (2) Radha Charan Gorai (24) S/O- Nirmal Gorai both of Vill- Sutaboi, PS-Kashipur, Dist- Purulia (3) Intaj Ansari (31) S/O- Safu Ansari (4) Noor Mohammad Ansari (33) S/O- Safu Ansari both of Vill-Jamkuri, PS-Kashipur, Dist-Purulia, 5) Sayed Ansari(32) S/O- Rashid Ansari of Vill-Kuldih, PS- Kashipur, Dist- Purulia under proper law.
