Sir,

In producing herewith arrested accused person namely Md. Hannan (32 Yrs)
S/O Alimdad Mirdna of Vill-Bamarra, PS-Raghunathpur, Dist- Purulia along with
seized articles (1) One Black and Blue colour combination Hero Honda CD Deluxe
Motorcycle, bearing Reg. No-JH10V/7901.

I beg to report that today myself along with C/522 Ruplal Tudu and C/1272
Bikash Chandra Patra both of Adra PS were performing special mobile duty at
Kashipur More under Adra PS, vide Adra PS C.C No-4468/21 dtd.30.12.2021 and
Adra PS GDE No-1230. At about 16:25 hrs, I found one Black and Blue colour
combination Hero Honda CD Deluxe Motorcycle, bearing Reg. No-
JH10V/7901 coming from Raghunathpur side towards Kashipur side rashly and
negligently. We try to stop him but the rider of the said motorcycle named in above
was trying to escape the place so rashly, there was every possibility of loss/ serious
injury of nearby public due to his such riding. After a hot chase we could able to stop
him. On being asked, he stated his name and address as noted above, but unable to give
any satisfactory account for his such rush and negligent driving which may cause
endanger to human life.

So, I arrested him as he violated sec 279 IPC and 184 MV Act 1988 at about
16:45 hrs. I also seized the motor cycle with a view to prosecute him U/S 279 IPC and
184 MV Act 1988 in presence of police party. As the place is lonely so there is no
public present at that time. The whole process of seizure was completed in between
16:35 hrs to 16:45 hrs. His family member was also informed about the ground of
arrest.

Hence I pray that a specific case U/S 279 IPC and 184 MV Act 1988 may kindly
be initiated against accused Md. Hannan (32 Yrs) S/O Alimdad Mirdha of Vill-
Bamarra, PS-Raghunathpur, Dist- Purulia.
