Sub:- To lodge FIR against owners and drivers of (i) Mahindra tractor having Regd. number WB55A-6092 along with trolley (ii) Tractor having Regd. number JH09-AD /6273 along with trolley (iii) Tractor having Regd. number WB55B-1802 along with trolley (iv) Tractor having Regd. number WB55A-6252 along with trolley (v) Mahindra without Regd. number, having eng. No. NJM2EAJ0716 and chassis no. MBNABAEXPJMM00737 along with trolley and (vi) Sonalika tractor without Regd. number, engine no. 3100FL73D636884F3 chassis no. FZJST642762SM along with trolley (each trolley loaded with sand approx 60 CFT each trolley).

In producing herewith, 06 (Six) (i) Mahindra tractor having Regd. number WB55A-6092 along with trolley (ii) Tractor having Regd. number JH09-AD /6273 along with trolley (iii) Tractor having Regd. number WB55B-1802 along with trolley (iv) Tractor having Regd. number WB55A-6252 along with trolley (v) Mahindra without Regd. number, having eng. No. NJM2EAJ0716 and chassis no. MBNABAEXPJMM00737 along with trolley and (vi) Sonalika tractor without Regd. number, engine no. 3100FL73D636884F3 chassis no. FZJST642762SM along with trolley. Today on 19.12.2021 at about 12:05 hrs. Acting on source information, I ASI Nivas Ch. Mahato of Arsha PS along with (i) C/-146 Maheswar Singh Sardar of Arsha PS (ii) C/- 307 Sankar Gorain (iii) C/342 Samir Mandal both of SAP 7th BN Camp at Arsha PS, Dist-Purulia, left for PS area vide Spl. C.C No. 138/21 Dtd. 19.12.2021. After we reached at Gouradag Ghat under Arsha PS at 12.55 hrs, we conducted raid on the Bank of River Kansai under Arsha PS and found that 06 (Six) Tractors along with trolleys attached with by a hinge was present at Gouradag Ghat on the Bank of River Kansai. Some persons were loading sand in the attached trolleys of said tractors. Seeing the Police party, those persons leaving the tractors (loaded with sand in the attached trolleys) at Gouradag Ghat, fled away. Police rushed to the Tractors and detained the said tractors. Police searched the said tractors and found that the tractors is loaded with sand and also searched surrounding but could not trace out the persons & drivers of said offending Tractors. Hence, I seized the above noted tractors along with trolleys and brought the tractors to Arsha PS. As there is every reason to believe that the drivers and owners of the said tractors with ill motive were transporting sand illegally without any valid document in support of carrying sand and violating the Govt. order they are doing such illegal activity.

Hence, I do hereby lodge this complaint against the owners and drivers of above noted tractors vide along with the trolleys and unknown others for investigation.
