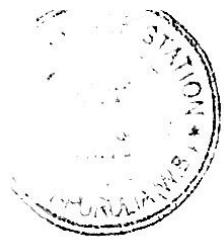

 I am producing herewith following arrested accused persons for the fact that, today (30.12.2021) during my special mobile duty (Arsha PS GDE No. 1175 dtd. 30.12.2021) with (i) C/853 Kiran Ch. Murmu of Arsha PS (ii) C/1140 Dayamaoy Mahato and (iii) C/146 Manheswar Singh Sardar Arsha PS area vide Arsha PS CC No. 2690/21 dtd 30/12/2021 had been at Jari Morh and found following arrested persons were wandering there without mask and afterwards detained them at the spot. Being asked, they could not be able to give any satisfactory answer for wandering there without mask of such type protective gear. As such all of them violated the Govt. Order during these Covid-19 pandemic situations. Furthermore, all those persons were making & circulating false alarm or warning as to disaster or its severity or magnitude, leading to panic among people as well as society. Accordingly, all were arrested between 19.45 hrs to 20.15 hrs and brought to PS (vide Order No. 753/IV-ISS/2M-22/2020 Dtd. 30.09.2021).
