Sir,

In producing here with one arrested accused person namely Arun Gorait (58 yrs) S/O Lt. Rahin Gorait of vill Palpal, P.S.-Arsha Dist-Purulia along with following seized articles.

- 1) One white colour plastic container containing approx 15 ltrs. of ID liquor.  
(Approx 500 ml taken out from of the above container as sample packed with sealing wax)

I, SI Uttam Kr. Mandal of Arsha PS do hereby lodge a written complaint against the above noted accused person to the effect that today i.e 10/12/2021 at about 16.55 hrs. during my Spl. mobile duty at Palpal side & Arsha PS area, receive source information over telephone that the above noted accused has been selling ID liquor in his house at Palpal village. On receiving the source information I communicated with O/C Arsha PS over telephone and as per his direction I along with C/- 694 Nikibuddin Khan and C/- 1140 Dayamoy Mahato both of Arsha PS rushed to the house of above noted suspected person to work out the information vide Arsha PS C.C. No. 2546/21 dtd. 10/12/2021. Reaching at Palpal village at about 17.35 hrs we fixed-up in the house of above noted accd. person and found that selling of I.D Liquor was going on there and having seen police all customers managed to escape, but we were able to apprehended the above noted accused person who was selling ID liquor. On demand he failed to produce any valid documents in support of selling ID liquor. So I seized one white colour plastic container containing approx 15 ltrs. of ID liquor under a proper seizure list from his exclusive possession in presence of witnesses and properly sealed and labeled duly signed by the accused person and witnesses among which approx 500 ml taken out from the above container as sample packed with sealing wax with label. During interrogation he confessed his guilt. So, I arrested him after observing all the formalities issuing memo of arrest as he was selling ID liquor illegally.

I therefore pray that a specific case may kindly be started against the accused person namely Arun Gorait (58 yrs) S/O Lt. Rahin Gorait of vill Palpal, P.S.-Arsha Dist-Purulia under proper section of law.


