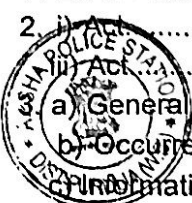

Respected Sir,

I am producing herewith following arrested accused persons for the fact that, today (10.12.2021) during my special mobile duty (Arsha PS GDE No. 417 dtd. 10.12.2021) with (i) C/1243 Abodh Ch. Mahato of Arsha PS (ii) C/288 Sourav Kr. Sribastav and (iii) C/307 Shankar Gorain both of SAP Arsha PS area vide Arsha PS CC No. 2548/21 dtd 10/12/2021 had been at Aharrah More and found following arrested persons were wandering there without mask and afterwards detained them at the spot. Being asked, they could not be able to give any satisfactory answer for wandering there without mask of such type protective gear. As such all of them violated the Govt. Order during these Covid-19 pandemic situations. Furthermore, all those persons were making & circulating false alarm or warning as to disaster or its severity or magnitude, leading to panic among people as well as society. Accordingly, all were arrested between 23.05 hrs to 23.30 hrs and brought to PS (vide Order No. 753/IV-ISS/2M-22/2020 Dtd. 30.09.2021).
