Sub: Request for lodging F.I.R. against arrested accused person Rakhhal Majhi (24Yrs) S/o-Bibhuti Majhi of Satra, PS- Arsha, Dist- Purulia.

Sir,

In producing herewith arrested accused person namely Rakhhal Majhi (24Yrs) S/o-Bibhuti Majhi of Satra, PS- Arsha, Dist- Purulia along with one seized Blue white colour Scooty bearing Registration No-WB 56Q-4147.

I beg to report that today myself along with C/1193 Monoranjan Bhuin of Arsha PS and C/451 Gulsan Kumar of SAP 7th BN camp at Arsha PS were performing evening mobile duty at Satra Morh under Arsha PS area vide Arsha PS C.C No-2576/21 dtd. 14.12.2021 and Arsha PS GDE No- 558 dtd-14.12.21 at about 18.35 hrs, I found one motor Cycle (scooty) bearing Registration No- WB56Q-4147 coming from Tamna Morh rashly and negligently. We try to stop him but the driver of the said motorcycle (Scooty) named in above was trying to escape the place so rashly, there was every possibility of loss/ serious injury of nearby public due to his driving. After a hot chase we could able to stop him. On being asked, he stated his name and address as noted above, but unable to give any satisfactory account for his such rush and negligent driving which may cause endanger to human life. So, I arrested him as he violated Sec. 279 IPC and I also seized the motor cycle (Scooty) in presence of witnesses. His family member was also informed about the ground of arrest.

Therefore I pray that a specific case may kindly be start against accused Rakhhal Majhi (24Yrs) S/o-Bibhuti Majhi of Satra, PS- Arsha, Dist- Purulia.
