On 14/12/2021 at about 04:15 p.m. I Sri Swapan Kumar Das, AE & Station Manager, Bagmundih CCC along with 1. Abdul Hasib, LM 2. Prabir Adhikary, O.S.H. entered the premises of Sri Kajal Goswami, S/O Nilmadhab Goswami of village - Bagmundi, P.O. - Bagmundi P.S- Bagmundi, Dist- Purulia and found Sri Kajal Goswami was enjoying electricity unauthorizedly drawing power from the nearest L & MV line of WBSEDCL through PVC wire by means direct hooking to his house premises and connected load found 0.1 KVA. 
