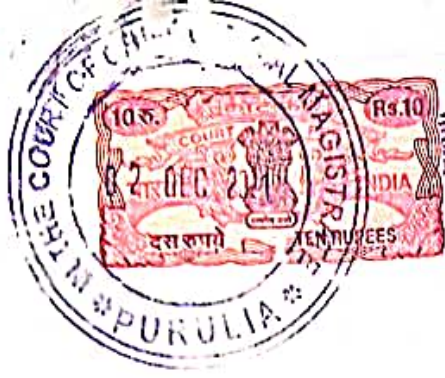

- 1...That the Complainant and injured person are the permanent resident of Village & P.O.Biramdih,P.S.- Balarampur, District Purulia which is within the jurisdiction of this Ld.Court.
- 2...That the accused person Shyamal Das is the permanent resident of Village & P.O.Biramdih P.S.Balarampur, District Purulia.
- 3..That Swapan Das & Shyamal Das belongs to same family and Shyamal Das is creating problem and disturbing the peaceful life of the Complainant and his family members.
- 4...That on the day of MA KALI PUJA ,the family members of the Complainant were observing festival of KALI PUJA
- 5...That on 4.11.2021.in the afternoon/ Manoj Das S/o Swapan Das went to watch & observe & celebrate MA KALI PUJA FESTIVAL while he was returning back his house at about 5 P.M.Shyamal Das S/o Late Anil Chandra Das of same village wrongfully restrained the minor child Manoj Das near by Railway Station Biramdih .
- 6..That the accused person Shyamal Das started using filthy languages against the parents of Manoj Das and threatened with dire consequences .
- 7...That the said accused Shyamal Das snatched away a silver chain from the body(Neck) of Manoj Das
