




Most Respectfully sheweth: -









- 1...That the Complainant and injured person are the permanent resident of Village & P.O.Biramdih, P.S.-Balarampur, District Purulia which is within the jurisdiction of this Ld.Court.
- 2...That the accused person Shyamal Das is the permanent resident of Village & P.O.Biramdih P.S.Balarampur, District Purulia.
- 3..That Swapan Das & Shyamal Das belongs to same family and Shyamal Das is creating problem and disturbing the peaceful life of the Complainant and his family members.
- 4...That on the day of MA KALI PUJA, the family members of the Complainant were observing festival of KALI PUJA
- 5...That on :4.11,2021.in the afternoon Manoj Das S/o Swapan Das went to watch & observe & celebrate MA KALI PUJA FESTIVAL while he was returning back his house at about 5 P.M.Shyamal Das S/o Late Anil Chandra Das of same village wrongfully restrained the minor child Manoj Das near by Railway Station Biramdih .
- 6..That the accused person Shyamal Das started using filthy languages against the parents of Manoj Das and threatened with dire consequences.
- 7...That the said accused Shyamal Das snatched away a silver chain from the body (Neck) of Manoj Das

- 8..That thereafter Shyamal DaS took out a knife from his pocket and started to injure the minor child Manoj Das with his knife but Manoj Das any how fled away could save his life from the clutch of the accused person.
  - 9..That it Minor Manoj Das came to his house and narrated the incident to his mother and thereafter to his father and other local people.
  - 10..That it is fact that Shyamal Das has committed the e offences of wrongfully restraining the minor Manoj Das & thus such illegal activities which was dangerous to the life of Manoj Das and dangerous to safety of the said minor child Manoj Das.the accused person Shyamal Das has committed offence of theft a Silver Chainnwhich amounts to Rs.5000/- (Rupees Five thousand) and offences of criminal intimidation., Shyamal Das also threaten Manoj Das & the family members of the Complainant for committing murder for which there is danger to life & property of the minor child of Manoj Das and his parents.
  - 11...That the Complainant after having full knowledge of the fact offences committed upon his son went to Balaram-pur Thana for lodging F.I.R.against the above-named accused person.Shyamal Das.
  - 12...That the local police till today didn not make any G.D.E.or F.I.R.against the accused person Shyamal Das.
  - 12...That thereafter the Complainant went to the office of Superintendent of Police and narrated the incident and



and gave a written complaint before the Superintendent of Police Purulia but till today no action has been taken against the above named accused person Shyamal Das .Hence this Misc Petition is filed this Ld.Court for taking necessary action against Shyamal Das S/o Late Anil Chandra Das resident of Village & P.O.-Biramdih ,P.S.Balarampur, District Purulia.
