I, S.I Sanjay Diger of Balarampur P.S do hereby lodge a complaint as suomoto

against the driver of offending Tractor having Reg. No-WB55B/4182.

I like to note here that today i.e on 19.12.2021 I, S.I Sanjay Diger along with C/3131 Soumen Dolai, C/2311 Swapan Mahato in full uniform were engaged in special anti crime Naka duty at Salbani village more on Barabazar - Balarampur road vide Balarampur P.S GDE No- 1152 date-19.12.2021 & C.C. No- 3418/21 date-19.12.2021 & at about 11:15 hrs. we saw one Tractor having Reg. No-WB55B/4182 coming from Barabazar side with excessive speed and dangerously, accordingly, we signaled the vehicle to stop at checking point behind other vehicles which were also being checked but all of a sudden, the said Tractor approached towards Balarampur Chowk Bazar more. Which may cause any endangering the human life rash & negligently driving the Tractor which may cause any time accident to the road user. After long chased we can able to apprehend the Tractor at Hetyadih more on Barabazar - Balarampur road, but seeing the Police party the accused driver of offending Tractor fled away. We tried to apprehended him but became failed.

Hence I seized the offending Tractor having Reg. No-WB55B/4182 after preparing seizure list duly signed by Sanjoy Mahato S/O- Gopal Mahato of Vill-Tumrasole, P.O- Barabhum, P.S- Barabazar, Dist.-Purulia.

Under the above circumstances and fact, I therefore pray that a specific case may kindly registered against the driver of offending Tractor having Reg. No-WB55B/4182 for coming offence U/S- 279 IPC & r.w Sec. 177/183/184 MV Act 1988.
