I do here by brought under arrest accused person namely Md. Karim Ansari (47 yrs) S/O-Md. Umar Ali Ansari of Road No.13B, Johar Nagar, PS-Mango, Dist-East Singhbhum (Jharkhand) along with one seized Motor Cycle i.e One Red & Black colour HERO HONDA CD DELUXE Motor Cycle having bearing Number Plate JH-05AJ/5820, Chassis No-MBLHA11ERB9F09422, Engine No-HA11EDB9F13273 and lodging written complaint against him. The fact of the case in brief is that today i.e. on 21.12.21 at 16.55 hrs, I received a credible source information that one Md. Karim Ansari of Jamshedpur side (Jharkhand) is habitually dealing with stolen Motor Cycles since long knowing that those were procured by means of theft and today, he came at Kuilapal Indkuri Mor to sell a stolen motorcycle. Accordingly, noted the fact in G.D which refers to Bandwan PS GDE No-865 dtd 21.12.21 and myself along with force (vide C.C No-4295 dtd. 21.12.21) left for Kuilapal Indkuri Mor to work out the said source information.

Then, I detained the said Md. Karim Ansari at Kuilapal Indkuri Mor as per source information & seized One Red & Black colour HERO HONDA CD DELUXE Motor Cycle having bearing Number Plate JH-05AJ/5820, Chassis No-MBLHA11ERB9F09422, Engine No-HA11EDB9F13273 from his possession after preparing proper seizure list duly signed by the witnesses as he failed to produce any valid documents in respect of said seized Motor Cycle though sufficient time was given.

During interrogation, he confessed that he along with his other partners forming a gang is habitually dealing with stolen Motor Cycles since long knowing that those were procured by means of theft. After that, I arrest him after prepared proper arrest memo duly signed by the witness.

After returning to PS, I started Suo-Muto Bandwan PS Case No-78/2021 dtd. 21.12.2021 U/S-379/411/413/414/120B IPC against arrested accused person namely Md. Karim Ansari (47 yrs) S/O-Md. Umar Ali Ansari of Road No.13B, Johar Nagar, PS-Mango, Dist-East Singhbhum (Jharkhand) and other unknown miscreants.
