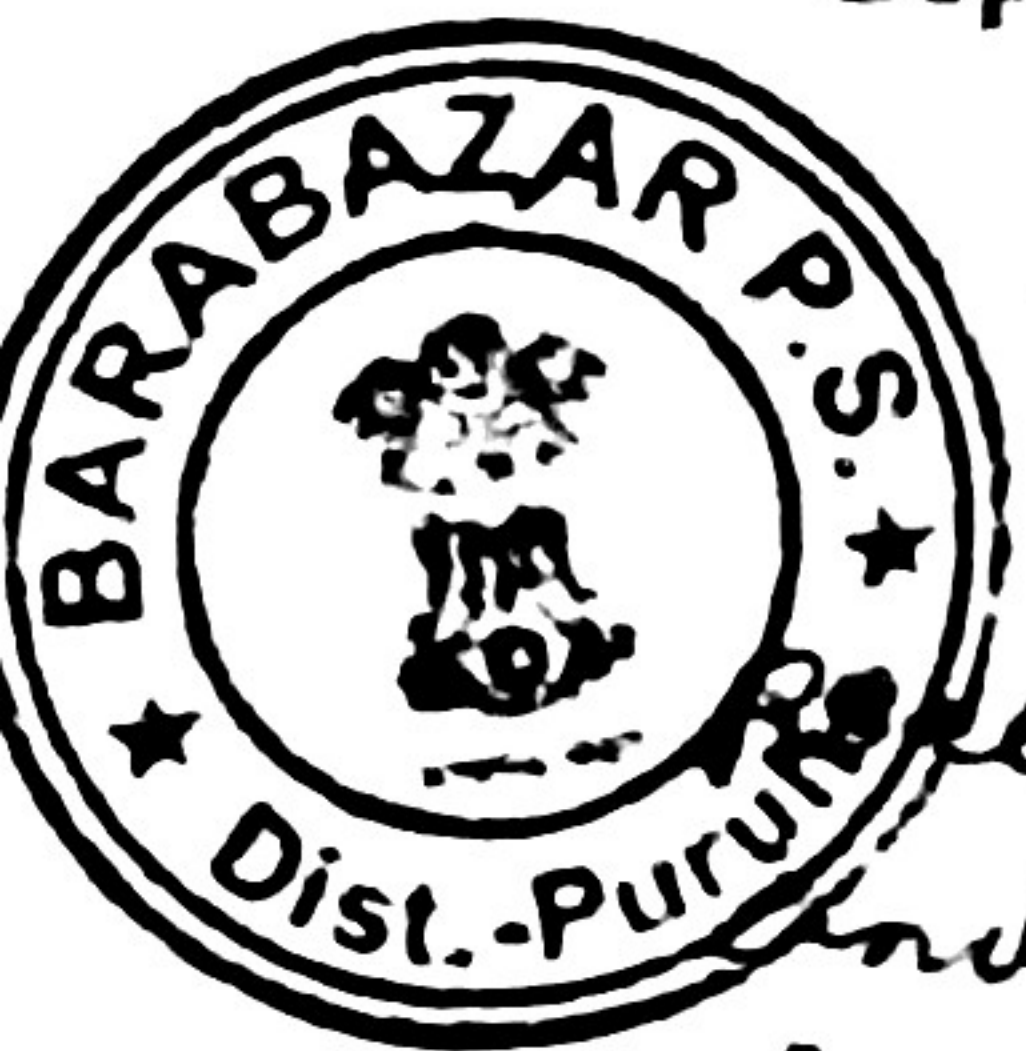

## NOTIFICATION

No. 570-For. 2P-3-63—7th February 1967.—Whereas the Governor thinks that in the case of the forest lands situated within the district of Poreulia and described in the schedule below, the inquiry and record referred to in sub-section (3) of section 29 of the Indian Forest Act, 1927 (XVI of 1927), will occupy such length of time as in the meantime to endanger the rights of Government,

Now, therefore, in exercise of the power conferred by the proviso to sub-section (3) of section 29 of the Indian Forest Act, 1927 (XVI of 1927), the Governor is pleased, pending such inquiry and record, to declare, with effect from the date of the publication of this notification in the "Calcutta Gazette", such forest lands to be protected forests.
