

Sub: Complaint against Karna Gorain (31 Yrs) S/o- Radhu Gorain of Vill- Dhadanga, PS-Barabazar, Dist-Purulia to start a specific case under proper section of Law.

Sir,

In producing here with arrested accused person namely Karna Gorain (31 Yrs) S/o-Radhu Goram of Vill- Dhadanga, PS- Barabazar, Dist- Purulia and seized (i) one Jerricane containing approx 14 (Fourteen) liters LD liquors in which 01 (one) liters taken as sample (ii) 04 (Four) pieces of plastic glass as per enclosed scizure list.

I, ASI Manas Kr. Pan of Barabazar PS do here by lodge this complaint against Karna Gorain (31 Yrs) S/o- Radhu Gorain of Vill- Dhadanga, PS- Barabazar, Dist- Purulia. I beg to state that on 30.12.2021 at about 16.35 hrs during my evening mobile duty I received telephonic information that one person was selling liquor in his house at Dhadanga village. I was there to verify the credibility of that information and immediately informed to the I.C. Barabazar PS. As per direction of I.C Barabazar PS myself along with C/- 677 Sayed Julhar Alı & C/- 1211 Chunaram Hembram had been to the spot by Govt. vehicle to work out the information. At about 17.15 hrs I detained one person at Dhadanga village under Tumrasole G.P who was selling liquor in his house. Seeing the Police party the alleged person and customers were tried to slee away, but I apprehended the seller with the help of the Police party and on being searched I found that the person stocking approx 14 (Fourteen) liters I.D liquors for selling. On demand, he failed to produce any valid documents / License in respect of stocking or selling of I.D liquors. On being asked he confessed his guilt and stated that he was stocking the I.D liquors with intent to sell to make his own profit. He disclosed his identity as Karna Gorain (31 Yrs) S/o- Radhu Gorain of Vill- Dhadanga, PS- Barabazar, Dist- Purulia. He also admitted that he has no license or any authorization for stocking & selling Country Spirit. Accordingly, I seized (i) one Jerricane containing approx 14 (Fourteen) liters I.D liquors (ii) 04 (Four) pieces of plastic glass after preparing proper seizure list and put label on the seized articles in presence of witnesses in which in which 01 (one) liters taken as sample which were also duly labeled by me and also took signature of the accompanying witness as well as accused person also on the Seizer list and label. The seizure and label was done in between 17.25 hrs and 17.35 hrs.

Thereaster, I secured arrest the accused person namely Karna Gorain (31 Yrs) S/o-Radhu Gorain of Vill- Dhadanga, PS- Barabazar, Dist- Purulia after preparing Memo of Arrest & after observing all other formalities regarding arrest as per Cr.PC and NHRC guideline. I informed him regarding the ground of arrest and his relatives regarding arrest. The arrest was made on 30.12.2021 at 17.45 hrs.

After returned to PS, I prepared this complaint and submitted before I.C Barabazar PS through Duty officer ASI Sadhan Ch. Danda to start a specific case against the arrested accused person namely Karna Gorain (31 Yrs) S/o- Radhu Gorain of Vill- Dhadanga, PS-Barabazar, Dist-Purulia under proper section of Law.
