Respected Sir,

In Producing herewith arrested accd person Rabi Lochan Mahato (32 Yrs), S/O- Buk Chand Mahato of Vill- Jagda PO- Kutni PS - Boro, Dist - Purulia along with seized articles.

I beg to report that on 08.12.2021, at 18.25 hrs in course of Spl. Mobile Duty I ASI Raju Mukherjee of Boro PS received an information from my source over telephone that huge number of wine bottles are staged in the house of Rabi Lochan Mahato (32 Yrs), S/O- Buk Chand Mahato of Vill- Jagda PO- Kutni PS - Boro, Dist- Purulia and the above noted person is selling Foreign Liquor in his respective house. Accordingly I ASI Raju Mukherjee informed to O/C Boro PS in this regard. As per direction of O/C Boro PS, I ASI Raju Mukherjee along with force rushed to village Jagda at the above noted said house to work out the information. At about 19.25 hrs myself along with force reached the spot and hold raid at the above noted house and found that the some persons were assembled and consuming liquor outside of the above noted house.

On seeing police party the assembled persons manage to flee away from the spot. On search there and found that the said person has selling the Foreign Liquor in his house. On demand, he failed to produce any valid papers/ documents in support of selling Foreign Liquor in his respective house. As such I seized (1) 41(Forty one) sealed bottles " McDowell's, No-1, Celebration, Matured XXX RUM" contains 180 ml of each bottles from the possession of above noted arrested accd person and duly signed by witnesses as well as the accd person and also prepared label. And arrested accd person namely Lochan Mahato (32 Yrs), S/O- Buk Chand Mahato of Vill- Jagda PO- Kutni PS - Boro, Dist - Purulia and brought to PS.

It may note here that during raid (1) C/357 Gopal Biswas, (2) C/ 1246 Sakti Pada Mahata accompanied me.

Therefore I pray before you that kindly arrange to started a specific case U/S -46A(C) B.E. Act. 1909 against arrested accd person Rabi Lochan Mahato (32 Yrs), S/O- Buk Chand Mahato of Vill- Jagda P.O- Kutni, PS - Boro, Dist - Purulia and arrange for its investigation.
