Sir,

In producing herewith arrested accused person namely Tarapada Hembram (20Yrs) S/O-
Chanda Hembram of Vill- Astagora, PS- Bandwan, Dist- Purulia along with one seized grey black
colour Hero Super Splendor Motor Cycle bearing Registration No-JH 05CR-1478.

I beg to report that today myself along with (1)C/851 Amrit Banerjee & (2) C/1246 Shakti
Pada Mahato both of Boro PS were performing Special day mobile duty at Burudih more under Boro
PS area vide Boro PS C.C No-2641/21 dtd.11.12.2021 and Boro PS GDE No-433 dtd- 11.12.21. At
about 11.55 hrs, I found one motor Cycle bearing Registration No- JH 05CR-1478 coming from
Dangardih more side rashly and negligently. We try to stop him but the driver of the said motorcycle
named in above was trying to escape the place so rashly, there was every possibility of loss/ serious
injury of nearby public due to his such driving. After a hot chase we could able to stop him. On being
asked, he stated his name and address as noted above, but unable to give any satisfactory account for
his such rush and negligent driving which may cause endanger to human life. On demand he also
could not produce his driving license and Insurance paper of the said vehicle.. So, I arrested him as
he violated Sec. 279 IPC and U/S- 181/184/196 M.V. Act. I also seized the motor cycle in presence
of witnesses. His family member was also informed about the ground of arrest.

Therefore I pray that a specific case may kindly be start against accused Tarapada Hembram
(20Yrs) S/O -Chanda Hembram of Vill- Astagora, PS- Bandwan, Dist- Purulia.
