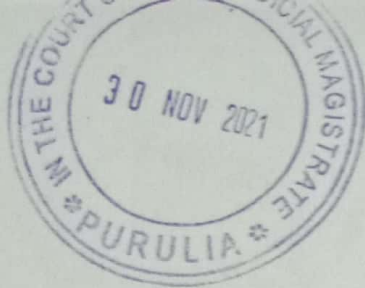

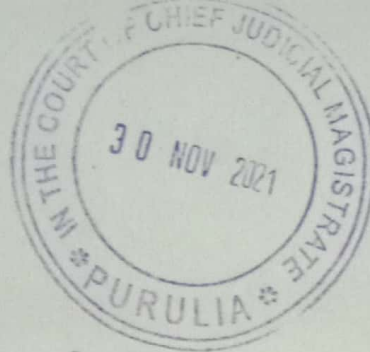

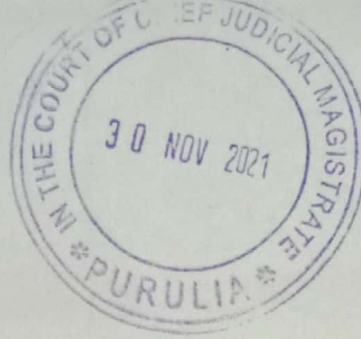
this petition is situated at mouza-Hullung, P.S.Hura, Dist.Purulia, within the jurisdiction of this court.

2.---That the schedule properties was previously belonged to Rakhahari Mahato. While Rakhahari Mahato was in physical possession of the schedule land he sold away the schedule property to the present complainant by demarcating the land and by executing and registered Sale Deed dated 18-03-1987 on valuable consideration and gave delivery of possession to the complainant. After purchase Present complainant came into physical possession then and there by cultivating paddy and harvesting the same since 18-03-1987.

3.---That like previous year, this year also present complainant manured the land, then cultivated the land and kept paddy seedling for transplanting the schedule land.

4.---That on 25-06-2021 at about 7 P.M. present accused persons No.1 to 4 making an unlawful assembly with greivous weapon along with one Tractor criminally tresspassed the schedule land and committed mischief by breaking southern Ail of the schedule land and destroyed the paddy seedling by ploughing the land with the help of Tractor. Due to the breaking of the ail and destroyed the paddy seedling, the complainant sustained loss of Rs.10,000/- (Rupees Ten thousand) .The complainant and his persons tried to resist them, but the accused persons No.1 to 4 threatened to kill the complainant and tried to

to kill the complainant by sword ,out of fear complainant fled away from the place of occurrence.

5.---That there after complainant informed the aforesaid incident to the local police of Hura P.S. But the police of Hura P.S. has not started any case . There after complainant informed the matter to the Superintendent of police Purulia, but still the police are quite mum and has not started any police case against the accused persons. Hence the present complainant is bound to file this case.

It is therefore prayed that your Honour may graciously be pleased to sent this complaint to Hura P.S. treating this petition as F.I.R. U/s 156(3) Cr.P.C.
