



There-after the Matter was brought to the C.C. Hura P.S. and requested them for an enquiry and also requested them for collecting the Money but Police of Hura P.S. but to ask the complainant to go to Ld:Court for filling Complaint.

That the accused person committed Various offences Punishable under the Indian Penal Code.
