In producing herewith one (01) arrested accd. person namely Kartik Gorai (54 yrs) S/O- Lt. Motilal Gorai of Vill- Kulgora, PS- Hura, Dist- Purulia, along with all seized article.

I beg to submit that today i.e on 30.12.21 during my Special mobile duty acting on a source information myself along with force had been to villager Kulgora at 19.25 hrs and held raid in the house of the above noted person and found that he is keeping/selling Country Spirit which was kept in his own position. On demand he failed to produce any valid document in respect of keeping and selling of said liquor. On asked he could not able to give any satisfactory answer about the keeping and selling the same. Finding no other alternative I seized and labeled 1. 16 (sixteen) sealed bottle of DIL Khus (Country Spirit) containing each 600 ml 2. 05 No of empty bottle of DIL Khus 3. 10 no of plastic glasses from the possession of said person under proper seizure list duly singed by the witnesses and also arrested him at 19:55 hrs. U/S 47 BE Act after followed all formalities as given by NHRC and Ld Supreme court .

The above noted arrested accd. namely Kartik Gorai (54 yrs) S/O- Lt. Motilal Gorai of Vill- Kulgora, PS- Hura, Dist- Purulia has committed offence u/s 46 A(c) B.E.Act. 1909 for unauthorized possession and sale of country spirit.

Under the fact and circumstances I pray before you that a case u/s 46 A (c) B.E.Act. 1909 may kindly be started against Kartik Gorai (54 yrs) S/O- Lt. Motilal Gorai of Vill- Kulgora, PS- Hura, Dist- Purulia and arrange for its investigation.
